A BILL

To direct the Secretary of Health and Human Services to finalize certain proposed provisions relating to the Programs of All-Inclusive Care for the Elderly (PACE) under the Medicare and Medicaid programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Comprehensive Care for*
5 *Seniors Act of 2018”.*

6 **SEC. 2. DIRECTING THE SECRETARY OF HEALTH AND**
7 **HUMAN SERVICES TO ISSUE A FINAL REGULA-**
8 **TION BASED ON THE PROPOSED REGULATION**
9 **RELATING TO THE PROGRAMS OF ALL-INCLU-**
10 **SIVE CARE FOR THE ELDERLY (PACE) UNDER**
11 **THE MEDICARE AND MEDICAID PROGRAMS.**

12 *Not later than December 31, 2018, the Secretary of*
13 *Health and Human Services shall issue a final regulation*
14 *based on the provisions of the proposed regulation titled*
15 *“Medicare and Medicaid Programs; Programs of All-Inclu-*
16 *sive Care for the Elderly (PACE)” (81 Fed. Reg. 54666).*

Amend the title so as to read: “A bill to direct the Secretary of Health and Human Services to issue a final regulation based on the proposed regulation relating to the Programs of All-Inclusive Care for the Elderly (PACE) under the Medicare and Medicaid programs.”.
