President-elect Biden,

Congratulations to you and Vice President-elect Kamala Harris on your momentous election victory to serve as the 46th President of the United States. As your team prepares to lead our nation, I am writing to encourage you to immediately rescind the Trump Administration's Executive Order 13950, "Combating Race and Sex Stereotyping," issued on September 22, 2020.

Executive Order 13950, which is based on the pernicious premise that diversity is "offensive and anti-American," effectively terminates diversity and inclusion training programs within all federal departments and agencies, the U.S. uniformed services, and among federal contractors, subcontractors, and certain federal grant recipients. Since its implementation, the Executive Order has resulted in the cancellation of diversity and training programs at the Departments of State, Justice, and Veterans Affairs and at branches of the U.S. uniformed services. Additionally, due to its wide-ranging scope, the order has also adversely impacted diversity and inclusion training programs within the private sector.

In hearings throughout the 116th Congress, the Financial Services Diversity and Inclusion Subcommittee, which I chair, has received testimony from industry leaders and experts acknowledging the positive correlation between diversity performance and the bottom line. President Trump's Executive Order is designed to eliminate the use of diversity and inclusion training programs that are essential in the prevention of discrimination, unconscious bias, and sexual harassment in the workplace and in promoting understanding, increasing profitability, and contributing to a more effective workforce.

As our nation prepares for the peaceful transfer of power from the Trump Administration to the Biden Administration, I am hopeful your Administration will take steps to promptly rescind this draconian policy. I appreciate your consideration and stand ready to assist your efforts to rebuild our economy and build back better.
