Dear Mr. Zamagias:

I am writing regarding the Trump Administration's decision to direct hospitals to stop reporting coronavirus data to the Centers for Disease Control and Prevention (CDC), which has collected this information since the beginning of the pandemic, and instead to send information to a portal run by your company through a contract awarded by the Department of Health and Human Services (HHS). Following this decision, CDC abruptly removed previously collected hospitalization data—which has been relied upon by public health experts, reporters, and the public to determine which states are running out of hospital capacity—from the agency's website, restoring it after a public outcry. I write to request documents and information regarding your company's contract with HHS and role in this decision.

For more than a decade, hospitals have used the National Healthcare Safety Network (NHSN) to report data on infectious disease hospitalizations to the CDC.³ On July 10, 2020, HHS sent a notice to hospitals directing them to stop reporting coronavirus hospitalization data to the NHSN site, effective July 15.⁴ Instead, hospitals were directed to begin reporting data through your company, which entered into a \$10.2 million contract with the HHS Assistant

Secretary for Preparedness and Response in April 2020.⁵ This sudden decision raises questions as to how your company received this contract and what steps you are taking to ensure the public retains full and complete access to this critical data.

Your company has previously been awarded a handful of small contracts with the Department of Veteran's Affairs, but your contract with HHS is nearly twenty times larger than all of your previous federal contracts combined.⁶ A public database identified this contract as a sole-source award—but that database was altered to state that the award was subject to full and open competition on July 17, 2020, the same day this Subcommittee wrote a letter to HHS seeking information on this contract.⁷

I am particularly concerned that the Administration has taken a fully operational, critically important public health reporting system offline and abruptly replaced it with a new system in the midst of an ongoing public health emergency. Experts have raised concerns that researchers, reporters, and the public may lose access to crucial data on hospitalizations as a result of this change in reporting, and the fact that the data was removed from CDC's website heightens this concern. Experts have also raised concerns that HHS does not have the same expertise as CDC in analyzing and reporting this type of critical data. The sudden switch to a new portal is especially alarming at a time when infection rates and hospitalizations are rising across most of the country, and many hospitals are reportedly at or near capacity.

Delays or problems in transitioning to the new system could have serious consequences for infection control and patient care at hospitals. Administration officials have reportedly

pressured hospitals to report through the new TeleTracking system by tying allocation of the coronavirus treatment Remdesivir to hospital reporting through your company's portal. ¹⁰ According to one report, HHS and the White House Coronavirus Task Force recently sent a letter to governors confirming that hospital reporting through the TeleTracking portal would be used to guide Remdesivir distributions. ¹¹

For all these reasons, we request the following documents and information by August 11, 2020. These requests are consistent with House Resolution 935, which established the Select Subcommittee on the Coronavirus Crisis "to conduct a full and complete investigation" of "issues related to the coronavirus crisis," including the "preparedness for and response to the coronavirus crisis, including … the acquisition, distribution, or stockpiling of protective equipment and medical supplies."

- 1. All documents and communications related to HHS's contract award to TeleTracking, including but not limited to documents and communications regarding:
 - a. your company's interest in procuring services to or contracting with the federal government;
 - b. any solicitation or request for proposals or offers;
 - c. any offer, bid, or proposal from your company, including type of competition and pricing information;
 - d. your company's contract with HHS and any agreements with subcontractors, vendors, or other third-party sellers;
 - e. the award, modification, or termination of any contract or purchase order; and
 - f. your company's performance under any contract or purchase order, including any deficiencies in performance; and
- 2. Documents sufficient to identify the ownership, controlling shareholders, subsidiaries, affiliates, and organizational structure of TeleTracking;
- 3. All communications with any federal employee, official, agent, representative, or volunteer, including but not limited to any White House or HHS employee, related to the collection of hospitalization data in response to the coronavirus pandemic or the transition of hospitalization data from the National Healthcare Safety Network to HHS Protect;

- 4. A list of all meetings or phone conferences with any federal employee, official, agent, representative, or volunteer, including but not limited to any White House or HHS employee, regarding the topics described in Request 1 or Request 3. Please include the date and time of the meeting or phone conference, names of all participants, and a brief description of the topics discussed;
- 5. All policies, protocols, or guidance, whether formal or informal, received from any federal employee, official, agent, representative, or volunteer, including but not limited to any White House or HHS employee, in connection with the transition from the National Healthcare Safety Network to HHS Protect, including but not limited to any guidance on TeleTracking's performance under the contract. If no guidance was supplied, please provide a brief description of all requests for such guidance and any responses received; and
- 6. A detailed explanation of how hospitalization data provided to HHS through your company's portal is reported, including the categories of data reported, when and where data is available to the public, and any differences in data reported through your company's portal compared to data previously reported through the NHSN.

In addition, the Select Subcommittee respectfully requests a staff briefing by August 11, 2020, to address these issues.

Responding to Oversight Committee Document Requests

- 1. In complying with this request, produce all responsive documents that are in your possession, custody, or control, whether held by you or your past or present agents, employees, and representatives acting on your behalf. Produce all documents that you have a legal right to obtain, that you have a right to copy, or to which you have access, as well as documents that you have placed in the temporary possession, custody, or control of any third party.
- 2. Requested documents, and all documents reasonably related to the requested documents, should not be destroyed, altered, removed, transferred, or otherwise made inaccessible to the Committee.
- 3. In the event that any entity, organization, or individual denoted in this request is or has been known by any name other than that herein denoted, the request shall be read also to include that alternative identification.
- 4. The Committee's preference is to receive documents in electronic form (i.e., CD, memory stick, thumb drive, or secure file transfer) in lieu of paper productions.
- 5. Documents produced in electronic format should be organized, identified, and indexed electronically.
- 6. Electronic document productions should be prepared according to the following standards:
 - a. The production should consist of single page Tagged Image File ("TIF"), files accompanied by a Concordance-format load file, an Opticon reference file, and a file defining the fields and character lengths of the load file.
 - b. Document numbers in the load file should match document Bates numbers and TIF file names.
 - c. If the production is completed through a series of multiple partial productions, field names and file order in all load files should match.
 - d. All electronic documents produced to the Committee should include the following fields of metadata specific to each document, and no modifications should be made to the original metadata:

BEGDOC, ENDDOC, TEXT, BEGATTACH, ENDATTACH, PAGECOUNT, CUSTODIAN, RECORDTYPE, DATE, TIME, SENTDATE, SENTTIME, BEGINDATE, BEGINTIME, ENDDATE, ENDTIME, AUTHOR, FROM, CC, TO, BCC, SUBJECT, TITLE, FILENAME, FILEEXT, FILESIZE, DATECREATED, TIMECREATED, DATELASTMOD, TIMELASTMOD,

INTMSGID, INTMSGHEADER, NATIVELINK, INTFILPATH, EXCEPTION, BEGATTACH.

- 7. Documents produced to the Committee should include an index describing the contents of the production. To the extent more than one CD, hard drive, memory stick, thumb drive, zip file, box, or folder is produced, each should contain an index describing its contents.
- 8. Documents produced in response to this request shall be produced together with copies of file labels, dividers, or identifying markers with which they were associated when the request was served.
- 9. When you produce documents, you should identify the paragraph(s) or request(s) in the Committee's letter to which the documents respond.
- 10. The fact that any other person or entity also possesses non-identical or identical copies of the same documents shall not be a basis to withhold any information.
- 11. The pendency of or potential for litigation shall not be a basis to withhold any information.
- 12. In accordance with 5 U.S.C.§ 552(d), the Freedom of Information Act (FOIA) and any statutory exemptions to FOIA shall not be a basis for withholding any information.
- 13. Pursuant to 5 U.S.C. § 552a(b)(9), the Privacy Act shall not be a basis for withholding information.
- 14. If compliance with the request cannot be made in full by the specified return date, compliance shall be made to the extent possible by that date. An explanation of why full compliance is not possible shall be provided along with any partial production.
- 15. In the event that a document is withheld on the basis of privilege, provide a privilege log containing the following information concerning any such document: (a) every privilege asserted; (b) the type of document; (c) the general subject matter; (d) the date, author, addressee, and any other recipient(s); (e) the relationship of the author and addressee to each other; and (f) the basis for the privilege(s) asserted.
- 16. If any document responsive to this request was, but no longer is, in your possession, custody, or control, identify the document (by date, author, subject, and recipients), and explain the circumstances under which the document ceased to be in your possession, custody, or control.
- 17. If a date or other descriptive detail set forth in this request referring to a document is inaccurate, but the actual date or other descriptive detail is known to you or is otherwise apparent from the context of the request, produce all documents that would be responsive as if the date or other descriptive detail were correct.

- 18. This request is continuing in nature and applies to any newly-discovered information. Any record, document, compilation of data, or information not produced because it has not been located or discovered by the return date shall be produced immediately upon subsequent location or discovery.
- 19. All documents shall be Bates-stamped sequentially and produced sequentially.
- 20. Two sets of each production shall be delivered, one set to the Majority Staff and one set to the Minority Staff. When documents are produced to the Committee, production sets shall be delivered to the Majority Staff in Room 2157 of the Rayburn House Office Building and the Minority Staff in Room 2105 of the Rayburn House Office Building.
- 21. Upon completion of the production, submit a written certification, signed by you or your counsel, stating that: (1) a diligent search has been completed of all documents in your possession, custody, or control that reasonably could contain responsive documents; and (2) all documents located during the search that are responsive have been produced to the Committee.

Definitions

- 1. The term "document" means any written, recorded, or graphic matter of any nature whatsoever, regardless of how recorded, and whether original or copy, including, but not limited to, the following: memoranda, reports, expense reports, books, manuals, instructions, financial reports, data, working papers, records, notes, letters, notices, confirmations, telegrams, receipts, appraisals, pamphlets, magazines, newspapers, prospectuses, communications, electronic mail (email), contracts, cables, notations of any type of conversation, telephone call, meeting or other inter-office or intra-office communication, bulletins, printed matter, computer printouts, teletypes, invoices, transcripts, diaries, analyses, returns, summaries, minutes, bills, accounts, estimates, projections, comparisons, messages, correspondence, press releases, circulars, financial statements, reviews, opinions, offers, studies and investigations, questionnaires and surveys, and work sheets (and all drafts, preliminary versions, alterations, modifications, revisions, changes, and amendments of any of the foregoing, as well as any attachments or appendices thereto), and graphic or oral records or representations of any kind (including without limitation, photographs, charts, graphs, microfiche, microfilm, videotape, recordings and motion pictures), and electronic, mechanical, and electric records or representations of any kind (including, without limitation, tapes, cassettes, disks, and recordings) and other written, printed, typed, or other graphic or recorded matter of any kind or nature, however produced or reproduced, and whether preserved in writing, film, tape, disk, videotape, or otherwise. A document bearing any notation not a part of the original text is to be considered a separate document. A draft or non-identical copy is a separate document within the meaning of this term.
- 2. The term "communication" means each manner or means of disclosure or exchange of information, regardless of means utilized, whether oral, electronic, by document or otherwise, and whether in a meeting, by telephone, facsimile, mail, releases, electronic

- message including email (desktop or mobile device), text message, instant message, MMS or SMS message, message application, or otherwise.
- 3. The terms "and" and "or" shall be construed broadly and either conjunctively or disjunctively to bring within the scope of this request any information that might otherwise be construed to be outside its scope. The singular includes plural number, and vice versa. The masculine includes the feminine and neutral genders.
- 4. The term "including" shall be construed broadly to mean "including, but not limited to."
- 5. The term "Company" means the named legal entity as well as any units, firms, partnerships, associations, corporations, limited liability companies, trusts, subsidiaries, affiliates, divisions, departments, branches, joint ventures, proprietorships, syndicates, or other legal, business or government entities over which the named legal entity exercises control or in which the named entity has any ownership whatsoever.
- 6. The term "identify," when used in a question about individuals, means to provide the following information: (a) the individual's complete name and title; (b) the individual's business or personal address and phone number; and (c) any and all known aliases.
- 7. The term "related to" or "referring or relating to," with respect to any given subject, means anything that constitutes, contains, embodies, reflects, identifies, states, refers to, deals with, or is pertinent to that subject in any manner whatsoever.
- 8. The term "employee" means any past or present agent, borrowed employee, casual employee, consultant, contractor, de facto employee, detailee, fellow, independent contractor, intern, joint adventurer, loaned employee, officer, part-time employee, permanent employee, provisional employee, special government employee, subcontractor, or any other type of service provider.
- 9. The term "individual" means all natural persons and all persons or entities acting on their behalf.
