## UNANIMOUS CONSENT AGREEMENT

*Ordered*, That at 5 p.m. on Monday, March 11, 2013, the Senate proceed to executive session to consider the following nominations: Richard Gary Taranto, of Maryland, to be United States Circuit Judge for the Federal Circuit and Andrew Patrick Gordon, of Nevada, to be United States District Judge for the District of Nevada.

*Ordered further*, That there be 30 minutes for debate equally divided in the usual form; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nominations in the order listed; that the motions to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's action and the Senate then resume legislative session.
