Ordered, That at 5 p.m. on Monday, April 15, 2013, the Senate proceed to executive session to consider the nomination of Beverly Reid O'Connell, of California, to be United States District Judge for the Central District of California.

Ordered further, That there be 30 minutes for debate equally divided in the usual form; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nomination; that the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's action and the Senate then resume legislative session.

Ordered, That at a time to be determined by the Majority Leader, after consultation with the Republican Leader, the Senate proceed to Executive Session to consider the following nominations: Analisa Torres, of New York, to be United States District Judge for the Southern District of New York and Derrick Kahala Watson, of Hawaii, to be United States District Judge for the District of Hawaii.

Ordered further, That the Senate proceed to vote without intervening action or debate on the nominations in the order listed; that the motions to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's actions and the Senate then resume legislative session.
