Ordered further, That the motions to reconsider be considered made and laid upon the table; and that the President be immediately notified of the Senate's actions.

Ordered further, That the Senate then proceed to vote on the motion to invoke cloture on the nomination of Janet L. Yellen, of California, to be Chairman of the Board of Governors of the Federal Reserve System for a term of four years, as under the regular order, and if cloture is invoked on the Yellen nomination, all post-cloture time be yielded back.
