RESOLUTION

Providing for consideration of the bill (H.R. 986) to provide that certain guidance related to waivers for State innovation under the Patient Protection and Affordable Care Act shall have no force or effect, and providing for consideration of the bill (H.R. 2157) making supplemental appropriations for the fiscal year ending September 30, 2019, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule

1 XVIII, declare the House resolved into the Committee of
2 the Whole House on the state of the Union for consider-
3 ation of the bill (H.R. 986) to provide that certain guid-
4 ance related to waivers for State innovation under the Pa-
5 tient Protection and Affordable Care Act shall have no
6 force or effect. The first reading of the bill shall be dis-
7 pensed with. All points of order against consideration of
8 the bill are waived. General debate shall be confined to
9 the bill and shall not exceed one hour equally divided and
10 controlled by the chair and ranking minority member of
11 the Committee on Energy and Commerce. After general
12 debate the bill shall be considered for amendment under
13 the five-minute rule. The bill shall be considered as read.
14 All points of order against provisions in the bill are
15 waived. No amendment to the bill shall be in order except
16 those printed in part A of the report of the Committee
17 on Rules accompanying this resolution. Each such amend-
18 ment may be offered only in the order printed in the re-
19 port, may be offered only by a Member designated in the
20 report, shall be considered as read, shall be debatable for
21 the time specified in the report equally divided and con-
22 trolled by the proponent and an opponent, shall not be
23 subject to amendment, and shall not be subject to a de-
24 mand for division of the question in the House or in the
25 Committee of the Whole. All points of order against such

1 amendments are waived. At the conclusion of consider-
2 ation of the bill for amendment the Committee shall rise
3 and report the bill to the House with such amendments
4 as may have been adopted. The previous question shall
5 be considered as ordered on the bill and amendments
6 thereto to final passage without intervening motion except
7 one motion to recommit with or without instructions.

8 SEC. 2. At any time after adoption of this resolution
9 the Speaker may, pursuant to clause 2(b) of rule XVIII,
10 declare the House resolved into the Committee of the
11 Whole House on the state of the Union for consideration
12 of the bill (H.R. 2157) making supplemental appropria-
13 tions for the fiscal year ending September 30, 2019, and
14 for other purposes. The first reading of the bill shall be
15 dispensed with. All points of order against consideration
16 of the bill are waived. General debate shall be confined
17 to the bill and shall not exceed one hour equally divided
18 and controlled by the chair and ranking minority member
19 of the Committee on Appropriations. After general debate
20 the bill shall be considered for amendment under the five-
21 minute rule. An amendment in the nature of a substitute
22 consisting of the text of Rules Committee Print 116-12,
23 modified by the amendment printed in part B of the report
24 of the Committee on Rules accompanying this resolution,
25 shall be considered as adopted in the House and in the

1 Committee of the Whole. The bill, as amended, shall be
2 considered as the original bill for the purpose of further
3 amendment under the five-minute rule and shall be consid-
4 ered as read. All points of order against provisions in the
5 bill, as amended, are waived. Clause 2(e) of rule XXI shall
6 not apply during consideration of the bill. No further
7 amendment to the bill, as amended, shall be in order ex-
8 cept those printed in part C of the report of the Committee
9 on Rules. Each such further amendment may be offered
10 only in the order printed in the report, may be offered
11 only by a Member designated in the report, shall be con-
12 sidered as read, shall be debatable for the time specified
13 in the report equally divided and controlled by the pro-
14 ponent and an opponent, shall not be subject to amend-
15 ment, and shall not be subject to a demand for division
16 of the question in the House or in the Committee of the
17 Whole. All points of order against such further amend-
18 ments are waived. At the conclusion of consideration of
19 the bill for amendment the Committee shall rise and re-
20 port the bill, as amended, to the House with such further
21 amendments as may have been adopted. The previous
22 question shall be considered as ordered on the bill, as
23 amended, and any further amendment thereto to final pas-
24 sage without intervening motion except one motion to re-
25 commit with or without instructions.
