## RESOLUTION

Providing for consideration of the conference report to accompany the joint resolution (H.J. Res. 31) making further continuing appropriations for the Department of Homeland Security for fiscal year 2019, and for other purposes, and providing for proceedings during the period from February 15, 2019, through February 22, 2019.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider the conference report to ac-

1 company the joint resolution (H.J. Res. 31) making fur-  
2 ther continuing appropriations for the Department of  
3 Homeland Security for fiscal year 2019, and for other pur-  
4 poses. All points of order against the conference report  
5 and against its consideration are waived. The conference  
6 report shall be considered as read. The previous question  
7 shall be considered as ordered on the conference report  
8 to its adoption without intervening motion except: (1) one  
9 hour of debate; and (2) one motion to recommit if applica-  
10 ble.

11 SEC. 2. On any legislative day during the period from  
12 February 15, 2019, through February 22, 2019—

13 (a) the Journal of the proceedings of the pre-  
14 vious day shall be considered as approved; and

15 (b) the Chair may at any time declare the  
16 House adjourned to meet at a date and time, within  
17 the limits of clause 4, section 5, article I of the Con-  
18 stitution, to be announced by the Chair in declaring  
19 the adjournment.

20 SEC. 3. The Speaker may appoint Members to per-  
21 form the duties of the Chair for the duration of the period  
22 addressed by section 2 of this resolution as though under  
23 clause 8(a) of rule I.
