A BILL

To authorize appropriations for certain cooperative projects among the United States, Israel, and developing countries, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "United States-Israel
- 5 International Development Cooperation Act of 2019".

1	SEC. 2. STATEMENT OF POLICY AND MEMORANDUM OF UN-
2	DERSTANDING.
3	(a) STATEMENT OF POLICY.—It should be the policy
4	of the United States Agency for International Develop-
5	ment to seek to partner with Israel in order to advance
6	common goals across a wide variety of sectors, including
7	for projects relating to—
8	(1) energy, agriculture, and food security;
9	(2) democracy, human rights, and governance;
10	(3) economic growth and trade; and
11	(4) education, environment, global health,
12	water, and sanitation.
13	(b) Memorandum of Understanding.—The Ad-
14	ministrator of the United States Agency for International
15	Development is authorized to enter into a memorandum
16	of understanding with the appropriate officials of the Gov-
17	ernment of Israel in order to enhance coordination be-
18	tween the two countries on advancing the common goals
19	described in subsection (a)(1) through (a)(4) with a focus
20	on strengthening mutual ties and cooperation with other
21	countries throughout the world.
22	SEC. 3. COOPERATIVE PROJECTS AMONG THE UNITED
23	STATES, ISRAEL, AND DEVELOPING COUN-
24	TRIES.
25	Section 106(f) of the Foreign Assistance Λ ct of 1961
26	(22 U.S.C. 2151d) is amended to read as follows:

1	"(f) There is authorized to be appropriated
2	\$2,000,000 for each of fiscal years 2020 through 2024
3	to finance cooperative projects among the United States
4	Israel, and developing countries that identify and support
5	local solutions to address sustainability challenges relating
6	to water resources, agriculture, and energy storage, in-
7	eluding for the following activities:
8	"(1) Establishing public-private partnerships.
9	"(2) Supporting the identification, research, de-
10	velopment testing, and scaling of innovations that
11	focus on populations that are vulnerable to environ-
12	mental and resource-scarcity crises, such as subsist-
13	ence farming communities.
14	"(3) Seed or transition-to-scale funding, pub-
15	licity and marketing promotional support, or
16	mentorship and partnership brokering support.
17	"(4) Acceleration of demonstrations or applica-
18	tions of local solutions to sustainability challenges
19	or the further refinement, testing, or implementation
20	of innovations that have previously effectively ad-
21	dressed sustainability challenges.".
