14          Executive Office of the President and the Depart-

19          School Boards Association regarding threats at  
20          school board meetings or the Attorney General’s  
21          memorandum, dated October 4, 2021.

25          school board meetings or letter dated the September

1 29, 2021, from Dr. Viola M. Garcia and Chip Slaven  
2 to President Joseph R. Biden.

4 Executive Office of the President and the Depart-  
5 ment of Justice regarding threats at school board  
6 meetings or the letter, dated September 29, 2021,  
7 from Dr. Viola M. Garcia and Chip Slaven to Presi-  
8 dent Joseph R. Biden.

9 (6) The appointment of Dr. Viola M. Garcia to  
10 the National Assessment Governing Board.

11 (7) Communications sent or received or docu-  
12 ments in the possession of Mary C. Wall regarding  
13 threats at school board meetings, the letter, dated  
14 September 29, 2021, from Dr. Viola M. Garcia and  
15 Chip Slaven to President Joseph R. Biden, or the  
16 Attorney General's memorandum, dated October 4,
