Dear Mr. Dodaro:

We are writing to you in our capacities as Ranking Member and Vice-Ranking Member of the House Committee on Small Business. The Committee on Small Business is committed to overseeing the programs and operations of the U.S. Small Business Administration (SBA). Federal government procurement for goods and services leads to billions of dollars in contract awards annually. Federal contracting can also be an important revenue source for businesses of any size. The Small Business Act authorizes the Small Business Administration (SBA) to implement programs and further provide tools to small businesses to help them gain access to federal contracting opportunities. SBA's procurement center representatives (PCR) are an important component of this support. PCRs work with federal agencies by reviewing proposed acquisitions, recommending small business contract set-asides, and performing surveillance reviews (which monitor small business contracting at federal agencies). We are hereby asking for a GAO evaluation that focuses on the important role of SBA's PCRs.

A PCR's key responsibilities include making recommendations to agency contracting officers that proposed contracts be set aside for eligible small businesses – through informal and formal means. A PCR generally will issue an informal communication after discussing and reaching an agreement with a contracting officer to accept a recommended set-aside. If the PCR and contracting officer do not reach an agreement, the PCR can submit a formal action to the contracting officer. PCRs also have other avenues available to carry out their responsibilities.

Over the years, concerns have been raised about the number of PCRs employed by SBA, their effectiveness, and their location relative to where contract performance occurs.¹ Given these concerns, we ask that you address the following:

- 1. How many PCRs are employed by SBA, and how does SBA determine the resource level and geographic coverage needed to effectively carry out PCR responsibilities?
- 2. How does SBA evaluate the effectiveness of SBA's PCRs in helping small businesses, and to what extent are PCRs successful in helping small businesses gain access to federal contracting opportunities?
- 3. To what extent are PCRs receiving guidance, training, and supervisory support needed to effectively carry out their responsibilities?
