We the undersigned citizens of Twiggs County, Georgia, are individually and directly opposed to the passage of the Susan B. Anthony Amendment to the Constitution of the United States, thereby granting equal suffrage. In our opinions this is a question which should be settled by and through the action of each State for itself, and the enactment of such a law would deprive the States of the rights of being Commonwealths. To give equal suffrage in the South would only open the way to race riots, murder, and a repetition of the "Reconstruction Days of the Sixties". We most earnestly appeal to you to do what you can for our defense and protection in this most signal injustice.
