A BILL

To amend title 44, United States Code, to remove pronouns from such title that reference the Archivist, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Archives and
5 Records Administration (NARA) Modernization Act”.

6 **SEC. 2. AMENDMENTS.**

7 Title 44, United States Code, is amended—

8 (1) in section 710, by striking “his approval”
9 and inserting “approval by the President”;

1 (2) in section 711, by striking “he shall” and
2 inserting “the Director shall”;

3 (3) in section 2108—

4 (A) by striking “transferred to him” and
5 inserting “transferred to the Archivist”;

6 (B) by striking “appear to him” and in-
7 serting “appear to the head of the Federal
8 agency”;

9 (C) by striking “his custody” and inserting
10 “the custody of the head of the Federal agen-
11 cy”;

12 (D) by striking “he concurs,” and insert-
13 ing “the Archivist concurs”;

14 (E) by striking “his successor in function”,
15 each place it appears, and inserting “the suc-
16 cessor in function of the head of the agency”;
17 and

18 (F) by striking “he determines” and in-
19 serting “the Archivist determines”;

20 (4) in section 2109—

21 (A) by striking “to him” and inserting “to
22 the Archivist”; and

23 (B) by striking “He may” and inserting
24 “The Archivist may”;

25 (5) in section 2110—

1 (A) by striking “he considers” and insert-
2 ing “the Archivist considers”; and

3 (B) by striking “his custody” and inserting
4 “the custody of the Archivist”;

5 (6) in section 2112—

6 (A) by striking “he may”, each place it ap-
7 pears, and inserting “the Archivist may”;

8 (B) by striking “in him” and inserting “in
9 the Archivist”;

10 (C) by striking “his custody” and inserting
11 “the custody of the Archivist”; and

12 (D) by striking “his control” and inserting
13 “the control of the Archivist”;

14 (7) in section 2307, by striking “his designee”
15 and inserting “the designee of the Archivist”;

16 (8) in section 2903, by striking “by him” and
17 inserting “by the Archivist”;

18 (9) in section 3308, by striking “he may” and
19 inserting “the Archivist may”;

20 (10) in section 3310, by striking “he considers”
21 and inserting “the Archivist considers”; and

22 (11) in section 3311—

23 (A) by striking “his legal custody” and in-
24 serting “the legal custody of the head of the
25 agency of the United States Government”;

1 (B) by striking “his opinion” and inserting
2 “the opinion of such head of such agency”;

3 (C) by striking “he shall” and inserting
4 “such official shall”; and

5 (D) by striking “he disposed” and insert-
6 ing “such official disposed”.
