2 tronic or otherwise), or other communication in his posses-
3 sion, or any portion of any document, record, audio re-
4 cording, memorandum, call log, correspondence (electronic
5 or otherwise), or other communication, that refers or re-
6 lates to the following:

7 (1) The memorandum issued by the Attorney
8 General, dated October 4, 2021, and entitled “Part-
9 nership Among Federal, State, Local, Tribal, and
10 Territorial Law Enforcement to Address Threats
11 Against School Administrators, Board Members,
12 Teachers, and Staff”.

13 (2) Communication or coordination between the
14 Department of Justice and the Executive Office of
15 the President regarding the Attorney General’s
16 memorandum, dated October 4, 2021.

17 (3) Communication or coordination between the
18 Department of Justice and the National School
19 Boards Association regarding the Attorney General’s
20 memorandum, dated October 4, 2021.

21 (4) Communication or coordination between the
22 Department of Justice and the National School
23 Boards Association regarding threats at school
24 board meetings or the letter, dated September 29,

1 2021, from Dr. Viola M. Garcia and Chip Slaven to
2 President Joseph R. Biden.

3 (5) Communication or coordination between the
4 Department of Justice and the Executive Office of
5 the President regarding threats at school board
6 meetings or the letter, dated September 29, 2021,
7 from Dr. Viola M. Garcia and Chip Slaven to Presi-
8 dent Joseph R. Biden.

9 (6) Communication or coordination between the
10 Department of Justice and U.S. intelligence agencies
11 referring or relating to alleged threats posed by con-
12 cerned parents at local school board meetings, the
13 letter dated, September 29, 2021, from Dr. Viola M.
14 Garcia and Chip Slaven to President Joseph R.
15 Biden, or the Attorney General’s memorandum,
16 dated October 4, 2021.

17 (7) The Federal Bureau of Investigation’s
18 EDUOFFICIALS threat tag and investigations la-
19 beled with the EDUOFFICIALS threat tag.

20 (8) The total number of parents tagged by the
21 Federal Bureau of Investigation with the
22 EDUOFFICIALS threat tag.

23 (9) The Department of Justice task force “to
24 determine how federal enforcement tools can be used

- 1 to prosecute these crimes” and the National Security
- 2 Division’s role in the task force.
