I am requesting funding for the US 101/SR 92 Area Improvement Project in fiscal year 2022.

The entity to receive funding for this project is the City/County Association of Governments of San Mateo County (C/CAG) located at 555 County Center, Redwood City, CA 94063.

The funding would be used for infrastructure improvements including adequate ramp capacity and more efficient weaving and merging spacing where there is a higher than average collision rates at ramps and connectors. The project enhances safety and minimizes vehicle/pedestrian conflicts on local roadways, which have had an influx of regional cut-through traffic as motorists seek alternative routes avoiding congestion on U.S. 101 and S.R. 92. These improvements go hand in hand with a longer-term project the US 101/92 Direct Connector, which will redesign and rebuild a significant portion of the interchange. Both projects improve safety and operational efficiency for transit and drivers.
