## UNANIMOUS CONSENT AGREEMENTS

**Florence Y. Pan (Cal. No. 1067) (PN2193)**

**Amendment to Montreal Protocol (“Kigali Amendment”) (T. Cal. No. 2) (T. Doc. 117-1)**

*Ordered*, That upon the conclusion of morning business on Tuesday, September 20, 2022, the Senate proceed to executive session to resume consideration of the nomination of Florence Y. Pan, of the District of Columbia, to be United States Circuit Judge for the District of Columbia Circuit, post-cloture.

*Ordered further*, That at 11:30 a.m., all post-cloture time on the Pan nomination be considered expired.

*Ordered further*, That following disposition of the Pan nomination, the Senate recess until 2:15 p.m. to allow for the weekly caucus meetings.

*Ordered further*, That at 2:30 p.m., the Senate vote on the motion to invoke cloture on the resolution of ratification with respect to the Amendment to Montreal Protocol (“Kigali Amendment”).

*Ordered further*, That with respect to the motion to invoke cloture on the treaty, the mandatory quorum call required under Rule XXII be waived.

*Ordered further*, That if any nominations are confirmed during Tuesday’s session, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate’s actions. (*Sep. 15, 19, 2022.*)
