## **Summary of Changes to the EPW Reconciliation Title**

On January 7, 2022, the <u>legislative text</u> for reconciliation within the jurisdiction of the Senate Committee on Environment and Public Works (EPW) was publicly released. This document provides information on how the <u>Inflation Reduction Act of 2022</u> differs from the EPW title released in January.
