Veto unchallenged.

For the relief of G.B. Tyler and E.H. Luckett, assignees of William T. Cheatham.

Vetoed March 31, 1876. The veto message was laid before the Senate, referred to the Committee on Claims, and printed as S. Ex. Doc. No. 44. (4 Cong. Rec. 2180; *see also* S. Misc. Doc. No. 53, 49th Cong., 2d sess., p. 393).

The Senate overrode the veto on May 20, 1876 by a vote of 46 yeas to 0 nays. (4 Cong. Rec. 3229).

The House overrode the veto on May 26, 1876 by a vote of 181 yeas to 14 nays. (4 Cong. Rec. 3347).

Veto overridden. (19 Stat. 435).

156 S. 561.

For the relief of Major Junius T. Turner.

Vetoed August 15, 1876. The veto message was laid before the Senate, referred to the Committee on Military Affairs, and printed as S. Ex. Doc. No. 93. (4 Cong. Rec. 5665; *see also* S. Misc. Doc. No. 53, 49th Cong., 2d sess., p. 404). During the next session of Congress, the President withdrew his objections to the bill. No further action was taken by Congress. (5 Cong. Rec. 598).

Veto unchallenged.

157 S. 692.

To amend chapter 166 of the laws of the second session of the Forty-third Congress relating to the Fox and Wisconsin Rivers.

Vetoed June 30, 1876. The veto message was laid before the Senate. (4 Cong. Rec. 4339).

Veto unchallenged.

158 S. 779.

To provide for the sale of a portion of the reservation of the Confederated Otoe and Missouri and the Sac and Foxes of the Missouri Tribes of Indians in the States of Kansas and Nebraska.

Vetoed August 15, 1876. The veto message was laid before the Senate. (4 Cong. Rec. 5664; *see also* S. Misc. Doc. No. 53, 49th Cong., 2d sess., p. 403).

The House overrode the veto on July 28, 1876 by a vote of 177 yeas to 1 nay. (4 Cong. Rec. 4940).

The Senate overrode the veto on July 31, 1876 by a vote of 40 yeas to 0 nays. (4 Cong. Rec. 5011).

Veto overridden. (19 Stat. 472).

163 H.R. 1561.

Transferring the custody of certain Indian trust funds from the Secretary of the Interior to the Treasurer of the United States.

Vetoed February 3, 1876. The veto message was laid before the House, referred to the Committee on Appropriations, and printed as H.R. Ex. Doc. No. 118. (4 Cong. Rec. 881; *see also* S. Misc. Doc. No. 53, 49th Cong., 2d sess., p. 391).

Veto unchallenged.

164 H.R. 1922.

Providing for the recording of deeds, mortgages, and other conveyances affecting real estate in the District of Columbia.

Veto unchallenged.

To perfect the revision of the Statutes of the United States.

Vetoed February 14, 1877. The veto message was laid before the House. (5 Cong. Rec. 1613; *see also* S. Misc. Doc. No. 53, 49th Cong., 2d sess., pp. 409, 410).

The House sustained the veto on February 15, 1877 by a vote of 1 yea to 211 nays. (5 Cong. Rec. 1614).

Veto sustained.

To remove the charge of desertion of Alfred Rowland from military records.

Vetoed February 14, 1877. The veto message was laid before the House, referred to the Committee on Military Affairs, and printed as H.R. Ex. Doc. No. 39. (5

Cong. Rec. 1545; *see also* S. Misc. Doc. No. 53, 49th Cong., 2d sess., p. 409).

Veto unchallenged.

173 **H.R. 4350.**

To abolish the Board of Commissioners from the District of Columbia Police Department.

Vetoed January 23, 1877. The veto message was laid before the House. (5 Cong. Rec. 1111; *see also* S. Misc. Doc. No. 53, 49th Cong., 2d sess., pp. 405, 406).
