Ordered further, That following disposition of the AliKhan nomination, the Senate recess until 2:15 p.m. to allow for the weekly caucus meetings.

Ordered further, That at 2:30 p.m., the Senate vote on confirmation of the nominations of Amy Gutmann, of Pennsylvania, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Federal Republic of Germany and Lisa A. Carty, of Maryland, to be Representative of the United States of America on the Economic and Social Council of the United Nations, with the rank of Ambassador.

Ordered further, That if any nominations are confirmed during Tuesday's session, the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions.

Leonard Philip Stark, of Delaware, to be United States Circuit Judge for the Federal Circuit.
