Ordered, That upon the conclusion of morning business on Monday, July 11, 2022, the Senate proceed to executive session and resume consideration of the nomination of Ashish S. Vazirani, of Maryland, to be a Deputy Under Secretary of Defense.

Ordered further, That at 5:30 p.m., the cloture motions on the following nomination ripen:
Ashish S. Vazirani, of Maryland, to be a Deputy Under Secretary of Defense;
Steven M. Dettelbach, of Ohio, to be Director, Bureau of Alcohol, Tobacco, Firearms, and Explosives;
Michael S. Barr, of Michigan, to be a Member of the Board of Governors of the Federal Reserve System for the unexpired term of fourteen years from February 1, 2018; and
Michael S. Barr, of Michigan, to be Vice Chairman for Supervision of the Board of Governors of the Federal Reserve System for a term of four years.
