Ordered, That if cloture is not invoked on S. 4822 on Thursday, September 22, 2022, the Senate proceed to executive session to vote on confirmation of the nomination of Amanda Bennett, of the District of Columbia, to be Chief Executive Officer of the United States Agency for Global Media.

Ordered further, That upon disposition of the Bennett nomination, the Senate resume consideration of the nomination of Arati Prabhakar, of California, to be Director of the Office of Science and Technology Policy, and at 1:45 p.m. vote on confirmation of the Prabhakar nomination.

Ordered further, That the confirmation votes on the Bennett and Prabhakar nominations be at a time to be determined by the Majority Leader in consultation with the Republican Leader.

Ordered further, That if any nominations are confirmed during Thursday's session, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. (*Sep. 21, 2022*)
