
HERBERT HOOVER

President Hoover vetoed thirty-seven bills, of which twenty-one were regular vetoes and sixteen were pocket vetoes. Three were overridden (Item Nos. 1099, 1112, 1127). There were no vetoes in the first session of the Seventy-first Congress.

Seventy-first Congress, Second Session**Regular Vetoes****1099 S. 476.**

Granting pensions and increase of pensions to certain soldiers, sailors, and nurses of the War with Spain, the Philippine Insurrection, or the China Relief Expedition.

Vetoed May 28, 1930. The veto message was laid before the Senate and printed as S. Doc. No. 155. (72 Cong. Rec. 9713).

The Senate overrode the veto on June 2, 1930 by a vote of 61 yeas to 18 nays. (72 Cong. Rec. 9876).

The House overrode the veto on June 2, 1930 by a vote of 299 yeas to 14 nays. (72 Cong. Rec. 9914).

Veto overridden. (46 Stat. 492; Public Law 71-299).

1100 H.R. 1198.

To authorize the United States to be made a party defendant in any suit which may be commenced by the State of Oregon for the determination of the title to all or any of the lands constituting the beds of Malheur and Harney Lakes in Harney County, Oregon and for other purposes.

Vetoed June 6, 1930. The veto message was laid before the House, referred to the Committee on the Judiciary, and printed as H.R. Doc. No. 445. (72 Cong. Rec. 10237).

Veto unchallenged.

1101 H.R. 2029.

To authorize the coinage of silver 50-cent pieces in commemoration of the seventy-fifth anniversary of the Gadsden Purchase.

Vetoed April 21, 1930. The veto message was laid before the House, referred to the Committee on the Coinage, Weights and Measures, and printed as H.R. Doc. No. 354. (72 Cong. Rec. 7360, 7361).

The House sustained the veto on April 22, 1930 by a vote of 96 yeas to 244 nays. (72 Cong. Rec. 7460).

Veto sustained.

1102 H.R. 10381.

To amend the World War Veterans Act, 1924, as amended.

Vetoed June 26, 1930. The veto message was laid before the House and printed H.R. Doc. No. 495. (70 Cong. Rec. 11827, 11828).

The House sustained the veto on June 26, 1930 by a vote of 182 yeas to 188 nays. (72 Cong. Rec. 11828).

Veto sustained.

Pocket Vetoes

1103 S. 1909.

To extend the times for commencing and completing the construction of the bridge across the Rio Grande at Weslaco, Texas.

Pocket veto occurred in the 2d session of the 71st Congress during a recess from December 13, 1929 until January 6, 1930. The bill was presented to the President on December 13, 1929. (72 Cong. Rec. 580).

1104 S. 3853.

For the relief of Alexander M. Proctor.

Pocket veto occurred after the 2d session of the 71st Congress had adjourned sine die on July 3, 1930. The bill was presented to the President on July 3, 1930. (72 Cong. Rec. 12438).

1105 H.R. 2782.

For the relief of Elizabeth B. Dayton.

Pocket veto occurred after the 2d session of the 71st Congress had adjourned sine die on July 3, 1930. The bill was presented to the President on July 1, 1930. (72 Cong. Rec. 12265).

Seventy-first Congress, Third Session**Regular Vetoes****1106 S. 3165.**

Conferring jurisdiction upon the Court of Claims to hear, consider, and report upon a claim of the Choctaw and Chickasaw Indian Nations or Tribes for fair and just compensation for the remainder of the leased district lands.

Vetoed February 18, 1931. The veto message was laid before the Senate on February 20, 1931, referred to the Committee on Indian Affairs, and printed as S. Doc. No. 280. (74 Cong. Rec. 5467).

Veto unchallenged.

1107 S.J. Res. 49.

to provide for the national defense by the creation of a corporation for the operation of the Government properties at and near Muscle Shoals in the State of Alabama.

Vetoed March 3, 1931. The veto message was laid before the Senate and printed as S. Doc. No. 321. (74 Cong. Rec. 7046-7048).

The Senate sustained the veto on March 3, 1931 by a vote of 49 yeas to 34 nays. (74 Cong. Rec. 7098).

Veto sustained.

1108 H.R. 1036.

For the relief of Homer N. Horine.

Vetoed February 7, 1931. The veto message was laid before the House and printed as H.R. Doc. No. 738. (74 Cong. Rec. 4263).

The House sustained the veto on February 7, 1931 by a vote of 10 yeas to 278 nays. (74 Cong. Rec. 4264).

Veto sustained.

1109 H.R. 3368.

For the relief of Joseph Marko.

Vetoed February 23, 1931. The veto message was laid before the House and referred to the Committee on Military Affairs. (74 Cong. Rec. 5777, 5778).

Veto unchallenged.

1110 H.R. 6997.

To confer to certain persons who served in the Quartermaster Corps or under the jurisdiction of the Quartermaster General during the war with Spain, the Philippine Insurrection, or the China Relief Expedition the benefits of hospitalization and the privileges of the soldiers' homes.

Vetoed February 23, 1931. The veto message was laid before the House, referred to the Committee on Military Affairs, and printed as H.R. Doc. No. 778. (74 Cong. Rec. 5778).

Veto unchallenged.

1111 H.R. 13584.

To amend an act approved May 14, 1926 (44 Stat. 555), entitled "An act authorizing the Chippewa Indians of Minnesota to submit claims to the Court of Claims."

Vetoed February 24, 1931. The veto message was laid before the House, referred to the Committee on Indian Affairs, and printed as H.R. Doc. No. 780. (74 Cong. Rec. 5875).

Veto unchallenged.

1112 H.R. 17054.

To increase the loan basis of adjusted-service certificates.

Vetoed February 26, 1931. The veto message was laid before the House and printed as H.R. Doc. No. 790. (74 Cong. Rec. 6168-6170).

The House overrode the veto on February 26, 1931 by a vote of 328 yeas to 79 nays. (74 Cong. Rec. 6171).

The Senate overrode the veto on February 27, 1931 by a vote of 76 yeas to 17 nays. (74 Cong. Rec. 6230).

Veto overridden. (46 Stat. 1429; Public Law 71-743).

Pocket Vetoes

1113 S. 543.

To increase the pay of mail carriers in the village delivery service.

Pocket veto occurred after the 3d session of the 71st Congress had adjourned sine die on March 3, 1931. The bill was presented to the President on March 3, 1931. (74 Cong. Rec. 7099).

1114 S. 3060.

To provide for the establishment of a national employment system and for cooperation with the States in the promotion of such system.

Pocket veto occurred after the 3d session of the 71st Congress had adjourned sine die on March 3, 1931. The bill was presented to the President on February 25, 1931. (74 Cong. Rec. 5922).

1115 S. 3924.

For the relief of the First State Bank & Trust Co. of Mission, Texas.

Pocket veto occurred after the 3d session of the 71st Congress had adjourned sine die on March 3, 1931. The bill was presented to the President on February 28, 1931. (74 Cong. Rec. 6595).

1116 H.R. 8677.

For the relief of certain disbursing officers of the Army of the United States and for the settlement of individual claims approved by the War Department.

Pocket veto occurred after the 3d session of the 71st Congress had adjourned sine die on March 3, 1931. The bill was presented to the President on March 4, 1931. (74 Cong. Rec. 7394).

1117 H.J. Res. 357.

Classifying certain official mail matter.

Pocket veto occurred after the 3d session of the 71st Congress had adjourned sine die on March 3, 1931. The resolution was presented to the President on March 3, 1931. (74 Cong. Rec. 7250).

Seventy-second Congress, First Session

Regular Vetoes

1118 S. 826.

Conferring jurisdiction upon the Court of Claims to hear and determine claims of certain bands or tribes of Indians residing in the State of Oregon.

Vetoed April 25, 1932. The veto message was laid before the Senate, referred to the Committee on Indian Affairs, and printed as S. Doc. No. 89. (75 Cong. Rec. 9192).

Veto unchallenged.

1119 S. 2179.

For the relief of Alexander M. Proctor.

Vetoed February 26, 1932. The veto message was laid before the Senate, referred to the Committee on Military Affairs, and printed as S. Doc. No. 63. (75 Cong. Rec. 4780).

Veto unchallenged.

1120 S. 3847.

To amend the act approved March 3, 1931, relating to the rate of wages for laborers and mechanics employed by contractors and subcontractors on public buildings.

Vetoed July 1, 1932. The veto message was laid before the Senate and printed as S. Doc. No. 134. (75 Cong. Rec. 14589).

Veto unchallenged.

1121 H.R. 4724.

To confer to certain persons who served in the Quartermaster Corps, or under the jurisdiction of the Quartermaster General, during the War with Spain, the Philippine Insurrection, or the China Relief Expedition the benefits of hospitalization and the privileges of soldiers' homes.

Vetoed May 9, 1932. The veto message was laid before the House, referred to the Committee on Pensions, and printed as H.R. Doc. No. 315. (75 Cong. Rec. 9844).

Veto unchallenged.

1122 H.R. 6662.

To amend the Tariff Act of 1930, and for other purposes.

Vetoed May 11, 1932. The veto message was laid before the House, referred to the Committee on Ways and Means, and printed as H.R. Doc. No. 319. (75 Cong. Rec. 10035-10037).

The House sustained the veto on May 11, 1932 by a vote of 178 yeas to 166 nays. (75 Cong. Rec. 10039).

Veto sustained.

1123 H.R. 9575.

Granting pensions and increase of pensions to certain soldiers and sailors of the Regular Army and Navy, etc., and certain soldiers and sailors of wars other than the Civil War, and to widows of such soldiers and sailors.

Vetoed April 27, 1932. The veto message was laid before the House on May 3, 1932, referred to the Committee on Pensions, and printed as H.R. Doc. No. 322. (75 Cong. Rec. 9085).

Veto unchallenged.

1124 H.R. 12445.

To relieve destitution, to broaden the lending power of the Reconstruction Finance Corporation, and to create employment by authorizing and expediting a public works program and providing a method of financing such program.

Vetoed July 11, 1932. The veto message was laid before the House, referred to the Committee on Ways and Means, and printed as H.R. Doc. No. 360. (75 Cong. Rec. 15040, 15041).

Veto unchallenged.

Pocket Veto

1125 S. 4780.

Providing that advances under the Reconstruction Finance Corporation Act may be made for crop planting or crop cultivation, including summer fallowing, during the year 1932.

Pocket veto occurred after the 1st session of the 72d Congress had adjourned sine die on July 16, 1932. The bill was presented to the President on July 16, 1932. (75 Cong. Rec. 15643).

Seventy-second Congress, Second Session

Regular Vetoes

1126 S. 4340.

Authorizing the District Court of the United States for the Eastern District of Oklahoma to hear and determine certain claims of the Seminole Nation or Tribe of Indians.

Vetoed January 30, 1933. The veto message was laid before the Senate and printed as S. Doc. No. 177. (76 Cong. Rec. 2881).

Veto unchallenged.

1127 H.R. 7233.

To enable the people of the Philippine Islands to adopt a constitution and form a government for the Philippine Islands, to provide for the independence of the same, and for other purposes.

Vetoed January 13, 1933. The veto message was laid before the House and printed as H.R. Doc. No. 524. (76 Cong. Rec. 1759-1761).

The House overrode the veto on January 13, 1933 by a vote of 274 yeas to 94 nays. (76 Cong. Rec. 1768, 1769).

The Senate overrode the veto on January 17, 1933 by a vote of 66 yeas to 26 nays. (76 Cong. Rec. 1924).

Veto overridden. (47 Stat. 761; Public Law 72-311).

1128 H.R. 13975.

Making appropriations to supply urgent deficiencies in certain appropriations for the fiscal year ending June 30, 1933, and prior fiscal years, to provide supplemental appropriations for the fiscal year ending June 30, 1933.

Vetoed January 24, 1933. The veto message was laid before the House, referred to the Committee on Appropriations, and printed as H.R. Doc. No. 529. (76 Cong. Rec. 2445, 2446).

The House sustained the veto on January 24, 1933 by a vote of 193 yeas to 158 nays. (76 Cong. Rec. 2449).

Veto sustained.

Pocket Vetoes

1129 S. 5122.

To provide for the purchase and sale of cotton under the supervision of the Secretary of Agriculture.

Pocket veto occurred after the 2d session of the 72d Congress had adjourned sine die on March 3, 1933. The bill was presented to the President on March 3, 1933. (76 Cong. Rec. 5525).

1130 H.R. 792.

For the relief of William Joseph Vigneault.

Pocket veto occurred after the 2d session of the 72d Congress had adjourned sine die on March 3, 1933. The bill was presented to the President on March 1, 1933. (76 Cong. Rec. 5397).

1131 H.R. 5548.

For the relief of George Brackett Cargill, deceased.

Pocket veto occurred after the 2d session of the 72d Congress had adjourned sine die on March 3, 1933. The bill was presented to the President on March 1, 1933. (76 Cong. Rec. 5397).

1132 H.R. 7716.

To amend the Radio Act of 1927, as approved February 23, 1927, as amended.

Pocket veto occurred after the 2d session of the 72d Congress had adjourned sine die on March 3, 1933. The bill was presented to the President on March 1, 1933. (76 Cong. Rec. 5397).

1133 H.R. 10641.

To amend section 122 of the Judicial Code, relating to judges and judicial procedure.

Pocket veto occurred after the 2d session of the 72d Congress had adjourned sine die on March 3, 1933. The bill was presented to the President on March 3, 1933. (76 Cong. Rec. 5787).

1134 H.R. 13378.

To amend sections 416 and 417 of the revised Statutes relating to the District of Columbia.

Pocket veto occurred after the 2d session of the 72d Congress had adjourned sine die on March 3, 1933. The bill was presented to the President on March 1, 1933. (76 Cong. Rec. 5397).

1135 H.R. 14458.

Making appropriations for the executive Office and sundry independent executive bureaus, boards, commissions, and offices for the fiscal year ending June 30, 1934.

Pocket veto occurred after the 2d session of the 72d Congress had adjourned sine die on March 3, 1933. The bill was presented to the President on March 3, 1933. (76 Cong. Rec. 5596).
