A CONCURRENT RESOLUTION making application to the Congress of the United States to call a convention for the purpose of proposing an amendment to the Constitution of the United States in accordance with Article V of said Constitution.

1 BE IT RESOLVED *by the General Assembly of the State of New*
2 *Jersey (the Senate concurring):*

1 1. In accordance with the provisions of Article V of the Constitu-
2 tion of the United States of America, the Legislature of the State of
3 New Jersey hereby applies to the Congress of the United States to
4 call a Constitutional convention for the purpose of proposing an
5 amendment to the Constitution of the United States, which amend-
6 ment shall permit the offering of voluntary prayer in the public
7 school system.

1 2. If Congress shall have proposed an amendment to the Con-
2 stitution, to the same effect as the foregoing, prior to January 1,
3 1971, this application for a convention shall no longer be of any
4 force or effect.

1 3. Authenticated copies of this resolution shall be forwarded to
2 the Secretary of the Senate of the United States, the Clerk of the
3 House of Representatives of the United States, the members of the
4 ninety-first Congress of the United States elected from New Jersey
5 and the Secretary of the State of each of the several states for
6 transmittal by him to the Legislature of his respective state.
