Committee on Natural Resources – Markup Action Report

The Committee on Natural Resources met on Wednesday, September 21, 2022, to consider the following measures. H. Res. 1247 (Rep. Garret Graves), Of inquiry directing the Secretary of the Interior to transmit certain documents to the House of Representatives relating to the 2023-2028 five-year program for offshore oil and gas leasing.
