# **Risk Management Quality Teams Formed**

As promised by Richard Felder, DOT Associate Administrator for Pipeline Safety, at the November Risk Management Conference is Mc Lean, Virginia, a joint risk management quality team has been form to guide progress in risk management in the pipeline industry. The team has been formed under the sponsorship of the Office of Pipeline Safety (OPS), the American Petroleum Institute (API), and the Interstate Natural Gas Association of Regulatory Commissioners (NARUC), the National Association of Pipeline Safety Representatives (NAPSR), and the Gas Research Institute (GRI).



A Steering Team comprised of senior government and industry managers will provide strategic and policy level guidance. A Coordination & Communication Team will integrate the efforts of the Quality Team and other on-going OPS and industry risk management related activities, and is responsible for communication of the teams' activities with all sponsors and stakeholders. The Technical Team is responsible for developing an interim risk management standard that will describe the essential elements and characteristics of a pipeline company's risk management program. The interim standard can be
