- (3) Enter Rental Assistance Agreement Number from agreement being amended. If the existing agreement does not have a number, the Servicing Official will assign a number as prescribed in paragraph VD5 of Exhibit E to RD Instruction 1930-C.
- (4) Enter the date the agreement being amended was signed by the Servicing Official.
- (5) Enter the date(s) any modified agreement(s) was signed by the Servicing Official.
- (6) Enter the effective date shown on the agreement being amended.
- (7) Enter the legal name of the borrower as shown on the agreement being amended.
- (8) Enter sum of all obligations shown on the Servicing Office Rental Assistance Tracking record. (Servicing Office records reconciled with Finance Office balances.)
- (9) Enter borrower's name as shown on agreement being amended.
- (10) Signature(s) of borrower or person(s) presently authorized to sign for the borrower.
- (11) Title of person signing for the borrower, if applicable.
- (12) Date executed by borrower.
- (13) Signature of Servicing Official or person with delegation of authority to sign for the Servicing Official.
- (14) Title of person signing for the Rural Housing Service.
- (15) Date executed by the Rural Housing Service.
