(DAEOS) AND ETHICS COUNSELORS

The purpose of this memorandum is to appoint Deputy Designated Agency Ethics Officials and Ethics Counselors in accordance with para. 1-401 of reference (a).

As the Designated Agency Ethics Official, I am responsible for the implementation and administration of all aspects of the Department of the Navy ethics program. The Judge Advocate General of the Navy serves as the Alternate Designated Agency Ethics Official. He serves as the Designated Agency Ethics Official in my absence.

In accordance with para. 1-401 of reference (a), I hereby designate the following persons as Deputy Designated Agency Ethics Officials:

Principal Deputy General Counsel Counsel to the Commandant of the Marine Corps Deputy Judge Advocate General Director, Judge Advocate Division (Headquarters Marine Corps) Assistant General Counsel (Ethics)

Each of the Deputy DAEOs is responsible to me for ethics and standards of conduct matters within his organization. Their duties include providing advice on ethics and standards of conduct matters and finally reviewing, acting upon and maintaining the Department of the Navy Financial Disclosure Report (SF 278 and SF 450) systems.

The Assistant General Counsel (Ethics) is my primary assistant for ethics and standards of conduct matters. He is responsible for the management of the Department of the Navy ethics program and for working with other governmental agencies on matters relating to the Department of the Navy ethics program

The Counsel to the Commandant of the Marine Corps is responsible for the coordination and consistency of ethics opinions within the Marine Corps.

The Ethics Counselors designated in enclosure (1) are hereby delegated authority for initially reviewing Public Financial Disclosure Reports (SF 278) and for finally reviewing Confidential Financial Disclosure Reports (SF 450) within their organization, activity or geographic area. In addition, Ethics Counselors are responsible for providing advice (in writing whenever practical) and assisting on matters relating to ethics, standards of conduct, conflicts of interest, and post-Government service employment restrictions. Ethics Counselors are authorized to issue written opinions contemplated by 10 U.S.C. 2397a-b. Additional Ethics Counselors may be appointed by the Judge Advocate General; the Principal Deputy General Counsel; the Counsel to the Commandant of the Marine Corps; the Deputy Judge Advocate General; the Director, Judge Advocate Division (Headquarters, U.S. Marine Corps); the Assistant General Counsel (Ethics); or by me.
