Three suits have been brought against the Navy. They are Barbara Schwarz, Joseph Sheridan, and William G. Sproule. All three cases are pending.

10. The results of reviews undertaken in response to paragraph 3a of Appendix I to OMB Circular A-130.

- a. <u>Section (m) Contracts</u>: I certify that DON PA systems managers conducted a random sampling review of DON contracts that provide for the maintenance of a system of records on behalf of the agency in order to accomplish an agency function and that no discrepancies were found.
- b. Record keeping Practices: I certify that CNO (N09B30) is working closely with the DON system managers and the Navy's Records Management Branch to ensure that our systems of records notices are reviewed and that they comply with the DON's records disposal instruction, SECNAVINST 5212.5. This is an on-going process due to the need of the records manager to seek approval from the National Archives and Records Administration for the retention of DON records. When a discrepancy is discovered, an amendment is submitted to correct the notice.
- c. Routine Use Disclosures: I certify that my office routinely requests that DON PA systems managers have a review mechanism in place to ensure that each systems notice (to include routine use disclosures) are updated to reflect needed changes. Specifically, we target several commands annually to do an extensive review of their systems notices to ensure accuracy. Discrepancies, when discovered, are then quickly resolved.
- d. Exemption of Systems of Records: I certify that my office contacts annually those PA systems managers that have Section (j) and (k) exemptions to determine if such exemptions are still needed.

e. Systems of Records Notices: I certify that we have a mechanism in place to ensure that all systems of records notices that have not been updated in three to five years are reviewed to determine if they require amendment, deletion, or alteration. As a result of the 1999 Presidential Review, we deleted 25 systems of records; amended 68 systems of records, altered 2 systems of records, and confirmed the accuracy of 17 systems of records.

11. Describe Privacy Act training practices.

In an effort to educate all personnel, this Department has placed several training aides on our PA web site. The training aides which consist of brief sheets and slide show are used to conduct on-site training.

In 1999, we also hosted a PA/FOIA Training Roundtable for over 55 PA/FOIA specialists at our major commands; conducted specialized training for naval activities in Bangor, Washington; and for newly assigned supervisors through our Human Resources Office training program.

Many of our commands provide training during legal symposiums and to newly assigned personnel as part of their indoctrination brief.
