MAXIMUM INITIAL PERIODS OF ADMISSION AND EXTENSION FEES

In those cases in which there is a \$70 fee for an application for extension of stay, the applicant shall be advised that this fee must be paid for any application for extension necessitated by a passport having limited validity at the time of admission. INS regulations and Operations Instructions permit a maximum initial period of admission for nonimmigrants as follows:

¹ No additional fee for spouse or child included in principal alien's application; \$70.00 for spouse or child making separate application.

² Spouse or child desiring extension of stay must be included in principal alien's application, at no additional fee.

The period of admission may be limited to a lesser period in the discretion of the immigration authorities. The fee for an extension of stay must be paid at the expiration of the initial period of admission, and at the end of any subsequent period of stay granted if an application for further extension is submitted.
