WFHF funds spent on non-federal lands (S&PF): and "ownership attribute of the treatment unit. Ex. Federal or ownership type – predominant ownership; or break them up into different treatment units. Release 1.45 – Planned Release Date: June 1, 2003.

FY03 acres are being pulled for the WO TODAY for look at FRCC. These data calls are weekly and sometimes daily. If your Congress people don't see acres in your state, I'll give them your name... Out of 1.4MM ac target, 2MM acres are planned in NFPORS. **CURRENT CONDITION CLASS data is critical.** 44% data currently missing

Can we select T&E's in a grouping rather than selecting them individually?

Yes. This is in a change request. Coming soon

Can we select Communities at Risk other than by map?

Yes. Communities at risk are being revamped and so we will table changes until decisions are made regarding the new list of communities being revised by the states. Also on the change request list.

Deleting option: Users can delete activities as long as they're not accomplishments. Projects can be deleted by RO unless there are accomplishments associated with it. When you move an activity then zero out the activity and it can be deleted.

Is there a way to query community names?

The data set on the dash board contains a delimited list of community names. There may be Community 1, community 2 etc in the case of more than 1 community protected.

## Local treatment I.D.:

On change request. Looking for standard format for generating identifiers with out luck. Looking for local identifiers by the local unit. Appropriate to Regional arcIMS system tied to shape files. Want a field that ties polygons to NFPORS data. Look for next phase of NFPORS spatial integration. Want to be more interactive with the use map tool. When you go in to enter a new treatment location, the project location will also be displayed. You can see the FY01 and FY02 planned data are mapped and can be turned on in the use map. Should have near real time mapping capability. Looking for spatial data by FY05 planning entry phase (1 year next spring?). Need to link USGS and NFPORS databases in more real time.

Fuel treatments paid for by other ebli's may be counted?

When fuels is a 2y benefit, you can count that benefit. But, we don't have a mechanism. Budget suffix's are not available. Also, this may be entered in 2 different systems This needs to be coordinated with USDI. We want to be careful of inflating numbers. The problem is that timber is not tracking CC's.

There is a balance among databases and tracking.

Projects must be deleted at the Regional level.

Can costs be broken out for non-federal v. federal?

Yes based on acres on treatment unit. Ownership type is tied to treatment unit.

Payments to counties and colors of money are issues: John and Kristie to talk off line. May be a policy decision.

Are there plans to add to forest level reports at the treatment and activity level"

Yes. If you want them to be combined, download for the daily activity from the management dashboard.

Advanced excel activities: filtering, pivots, cross tabs workshop to be planned by Peter. Look for activities level report at the forest level. See management dashboard for daily dump for details. Under haz fuels there is the ability. Has a Brio plug into browser to do ad hoc clearing. Ex. What is planned at the district next week? Helpful to have some database mgmt knowledge to construct queries.

Congressional districts updates?

Data now available – (on use map??). Batch process based on lat long for updates.

Key Pt FY02 data: When will we see it? Coming soon.

There are no longer conversions from degrees minutes to lat long? Correct. Use use map.

Tracking of \$\$. Ex for NEPA. It they're not funded...

NEPA is in preliminary work plan. At the time that the budget comes and funding decisions are made. Go through preliminary work plan and move the unfunded into the next FY or delete it. Need for complete record management to keep unfunded projects from hanging on in old records. See obligation FY box = money's been obligated.

How to document treatments that are burned in wildfire? There is an interest in tracking these. Peter will investigate. Shall we track in NFPORS?
