Geoffrey L. Haskett was the Assistant Regional Director for Refuges and Wildlife in the Southeast Region of the U.S. Fish and Wildlife Service, in Atlanta, Georgia, from September 1994 to 1997. In this capacity, he was responsible for directing the Service's wildlife and

realty activities for the National Wildlife Refuge System in 10 Southeastern States, Puerto Rico, and the Virgin Islands and also served as Geographic Assistant Regional Director for the Region's southeastern ecosystems.

Prior to transferring to Atlanta, Mr. Haskett served in the Service's Washington Office from 1988 to 1994, originally as Branch Chief of Operations for the Division of Realty and ultimately serving for 3 years as the Chief of Realty for the Service and Secretary to the Department of the Interior's Migratory Bird Commission (other members included the Secretary of the Interior, Secretary of Agriculture, Administrator of the Environmental Protection Agency, and two Senators and two Representatives). Mr. Haskett received a Resolution of Appreciation from the Secretary of the Interior and the Migratory Bird Commission for his work as secretary to that body. During his time in Washington, Haskett also served on a detail to the Region 5 Regional Office as Acting Deputy Regional Director, in Hadley, Massachusetts.

From 1985 to 1988, Haskett worked for the National Park Service in Alaska as a Supervisory Realty Officer where he served as Deputy for the Alaska Lands Program. From 1980 to 1984, he was responsible for the Bureau of Land Management's realty and resource program for 3 I/2 million acres of public land in the Burns District, high desert country of Oregon.

Mr. Haskett started work with the Fish and Wildlife Service in 1979 in the Portland Regional Office. Prior to that, he spent a year as a VISTA Volunteer in the Department of Action.

Mr. Haskett holds a master's degree in public administration (1980), is a graduate of BLM's Oregon/Washington Management Development Program (1985), completed the Federal Executive Institute's Leadership for a Democratic Society (1993), and completed the Center for Creative Leadership Development Program (1997).

He is currently the Deputy Regional Director for the U.S. Fish and Wildlife Service's Southwest Region, located in Albuquerque, New Mexico. He arrived in the Region during the fall of 1997. Since that time, he has taken on the challenges facing this Region with great enthusiasm and looks forward to developing cooperative efforts throughout the Southwest area with state, local, and private agencies that can improve the protecting efforts of our natural resources.
