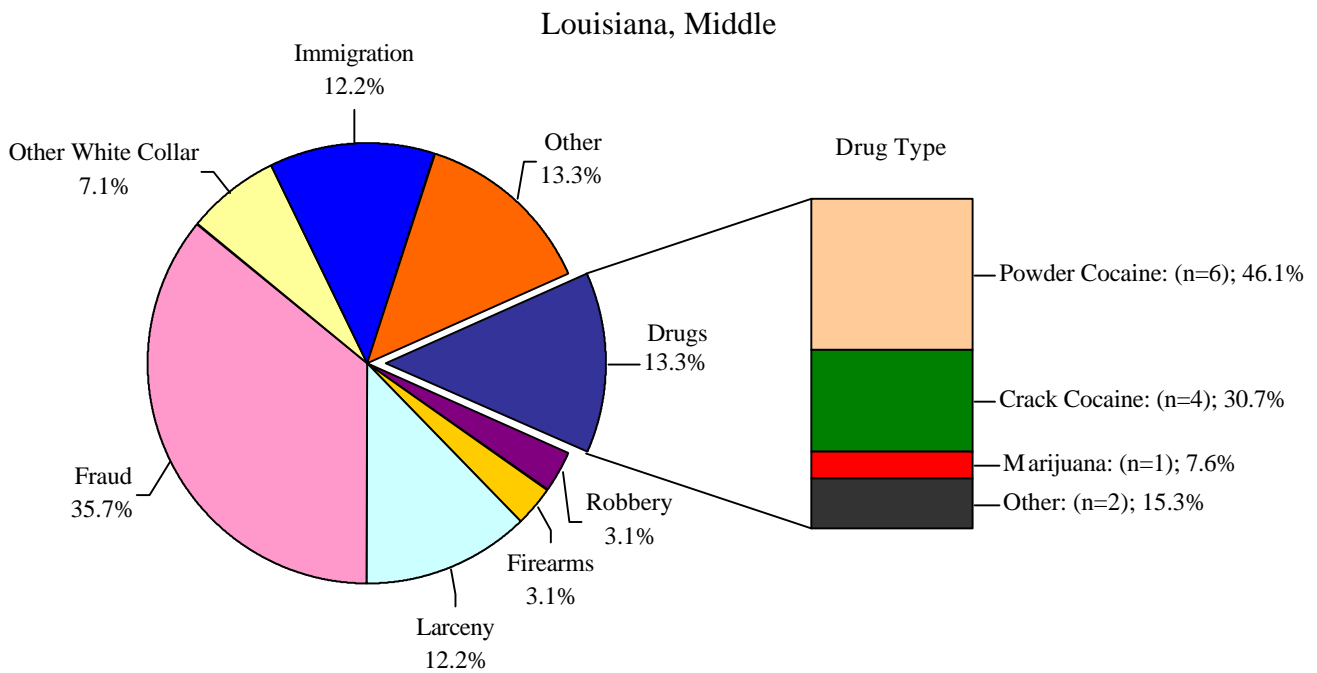
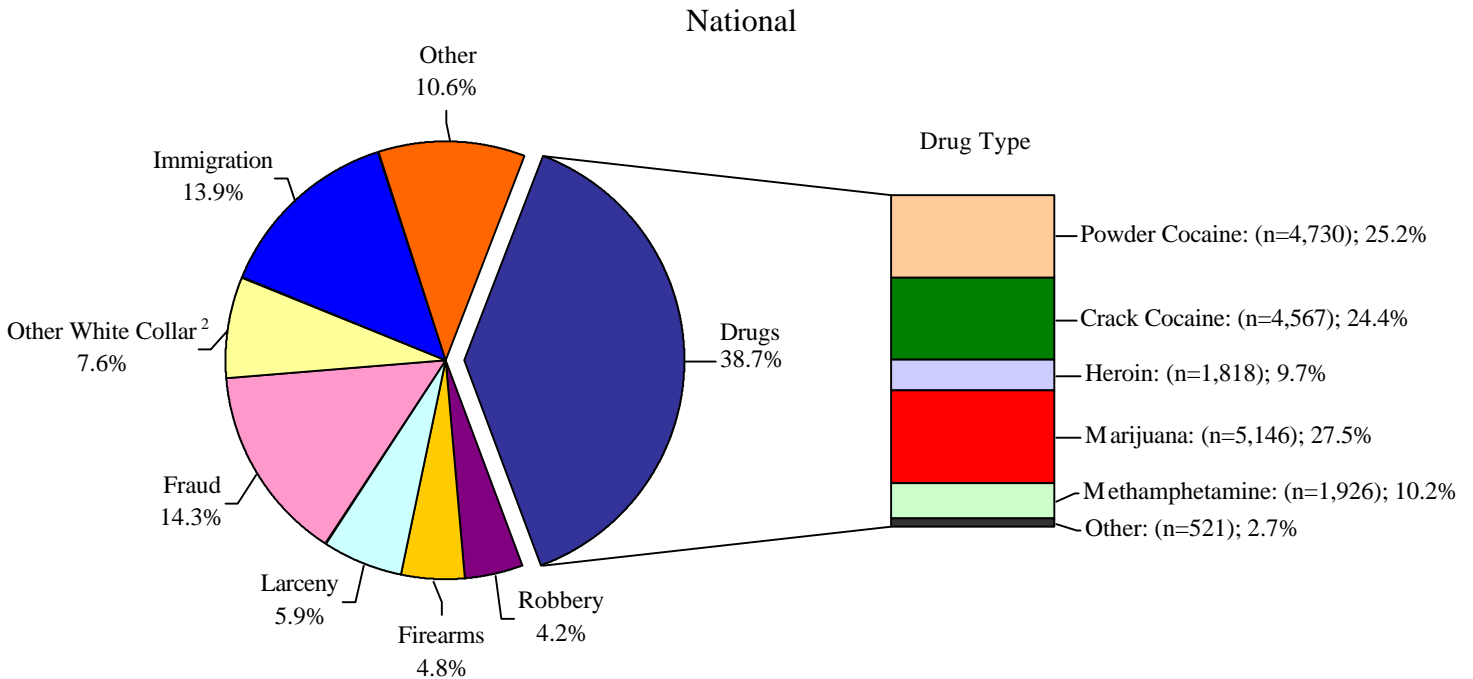

Of the 48,848 guideline cases, 332 cases with no analogous guidelines were excluded from the table. Of the remaining 48,516 cases, 2,499 cases were excluded due to missing departure information. Districts for which departure information is missing in five percent or more of the cases received included: Eastern Virginia (28.9%), Central New York (27.3%), Eastern New York (19.4%), Western Washington (16.6%), Northern Georgia (11.0%), Northern New York (10.9%), Northern Indiana (9.9%), Southern Florida (9.1%), Hawaii (8.9%), Southern California (8.6%), Oregon (7.5%), Eastern North Carolina (6.6%), Western Kentucky (6.6%), Northern California (6.5%), Colorado (6.2%), Massachusetts (5.3%), and Southern New York (5.0%).
