The Team will generally be mobilized with a compliment of 8 team members and 1 trainee.

Eastern Regions (NER, NCR, SER)

- 1. Park requests team through Regional Coordinator
- 2. After approval from Regional Director, Regional Coordinator passes request on to Team Coordinator.
- 3. Team Coordinator contacts available IC.
- 4. IC identifies team members and communicates team roster to Team Coordinator.
- 5. Team Coordinator communicates team roster to Regional Coordinator.
- 6. Regional Coordinator ensures Park or responsible dispatch office processes appropriate name request resource orders through the National Interagency Mobilization System.

Requesting Units from Other Regions (MWR, IMR, PWR, AKR)

- 1. Requesting Unit passes request on to Team Coordinator.
- 2. Team Coordinator contacts available IC.
- 3. IC identifies team members and communicates team roster to Team Coordinator.
- 4. Team Coordinator communicates team roster to Regional Coordinator.
- 5. Requesting Unit ensures appropriate name request resource orders are processed through the National Interagency Mobilization System.
