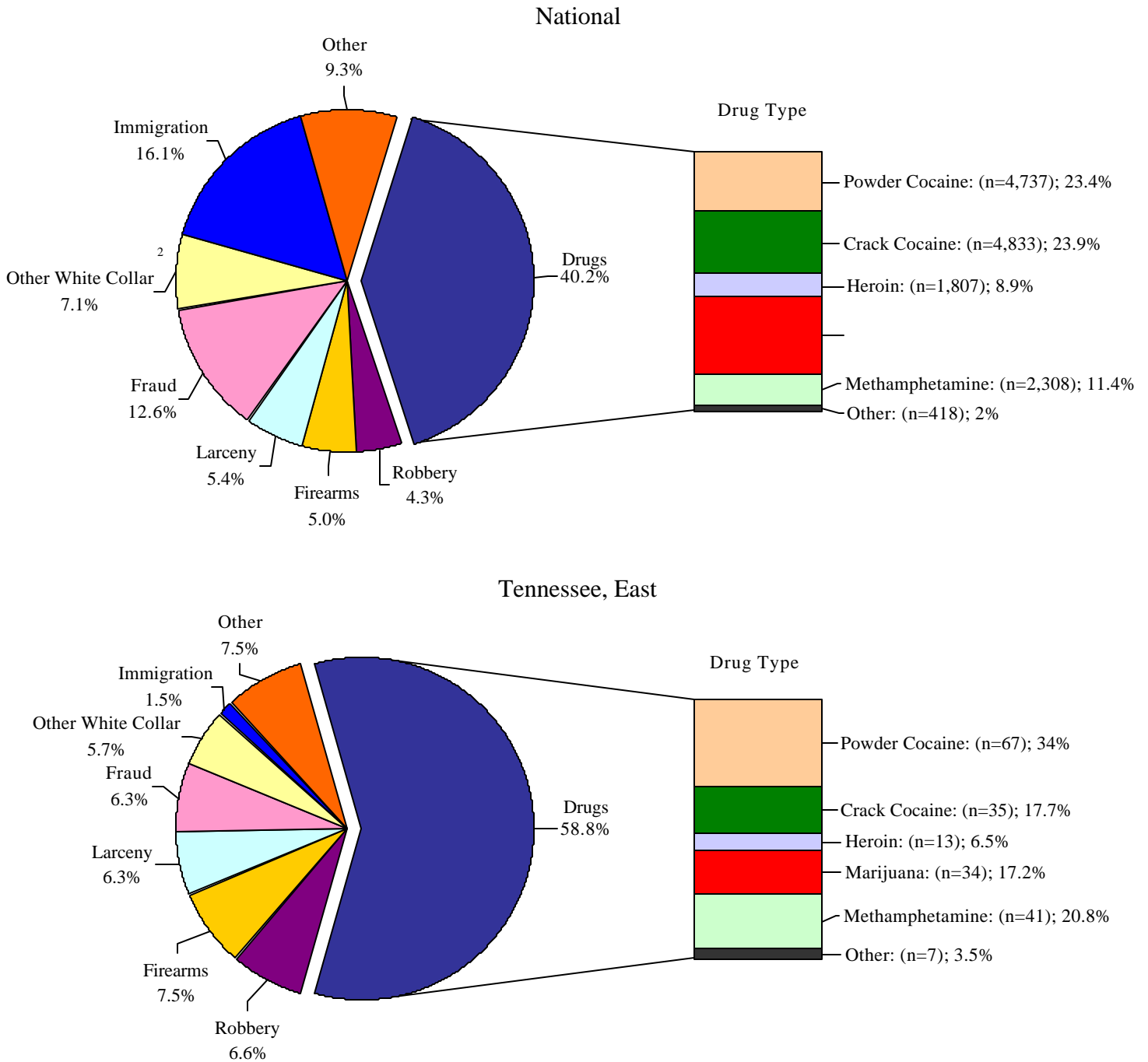

Of the 50,754 guideline cases, 8,803 cases with zero months prison ordered were excluded. In addition, 771 cases were excluded due to one or both of the following reasons: missing primary offense category (149) or missing or indeterminable sentencing information (677).

Of the 339 guideline cases from the Eastern District of Tennessee, 35 cases with zero months prison ordered were excluded. In addition, three cases were excluded due to missing or indeterminable sentencing information.
