¹Of the 64,366 cases, 10,203 received a substantial assistance departure. Of these, 9,741 had complete guideline application information. An additional 243 cases were excluded due to several logical criteria. Of the remaining 9,498 cases, 60 were excluded due to missing sentencing information.

²Cases with guideline minimums of life or probation (i.e., sentence lengths of zero months) were included in the sentence average computations as 470 months and zero months respectively, but were excluded from measures of decrease in the table.
