Excluded cases for the other Chapter Three adjustments were: Official Victim (54), Terrorism (198), Use of a Minor (31), Obstruction of Justice (54), and Reckless Endangerment (31). Descriptions of each guideline adjustment can be found in USSG Chapter Three.
