Of these, 28 were excluded from all calculations in the table, except those for Terrorism, Use of a Minor, Reckless Endangerment, and Acceptance of Responsibility, due to missing Chapter Three adjustment information. Excluded cases for the other Chapter Three adjustments were: Terrorism (180), Use of a Minor (20), Reckless Endangerment (20), and Acceptance of Responsibility (24). Descriptions of each guideline adjustment can be found in USSG Chapter Three.

Sourcebooks from Fiscal Year 1999 to 2001 contain a reporting error in this table for the number of cases which received both the Vulnerable Victim and Hate Crime enhancements under §3A1.1 (numbers for cases which received either the Vulnerable Victim or the Hate Crime adjustment alone are not in error).
