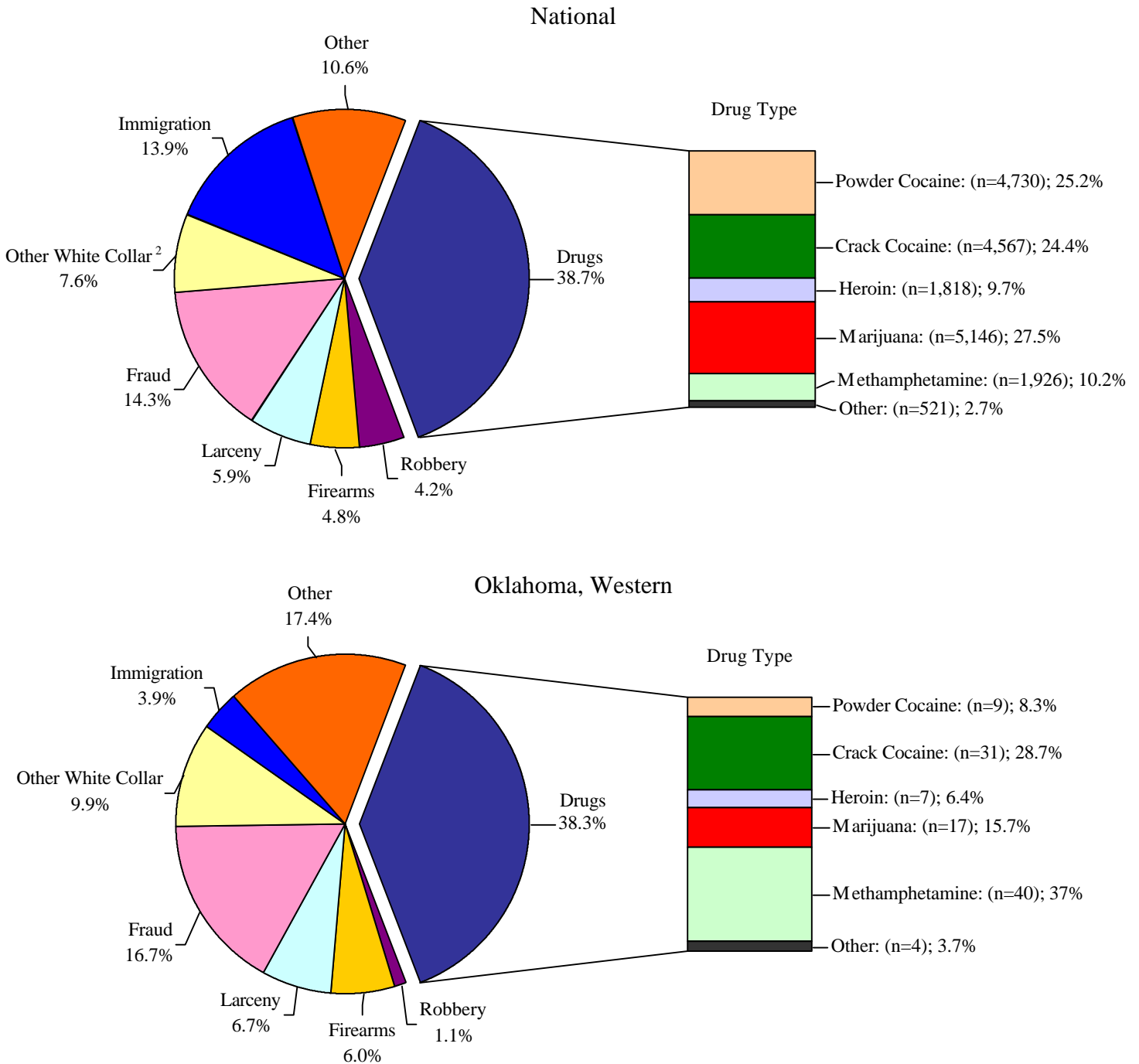

Of the 48,848 guideline cases, 10,017 cases with zero months prison ordered were excluded. In addition, 602 cases were excluded due to one or both of the following reasons: missing primary offense category (167) or missing or indeterminable sentencing information (498).

Of the 282 guideline cases from the District of Oklahoma, Western, 45 cases were excluded due to one of the following reasons: zero prison months ordered (43) or missing or indeterminable sentencing information (2).
