

EXPLANATION OF TERMS

RECIPIENT:

This identifies the individual or organization for which HHS funds have been obligated. In some cases it is impractical to specifically identify the recipient of HHS obligations. These are cases in which the funds are ultimately distributed to large number of people or organizations. Therefore, the recipient is shown as a collective group, rather than as a single recipient. For example, the recipient of program 93.774, "Medicare-Supplementary Medical Insurance," is shown as "Enrollee or Suppliers of Services."

AGENCY:

This refers to the major components of HHS known as "OPDIVs/Agencies." The OPDIV/Agency abbreviations are described on page vii.

CATALOG NUMBER/PROGRAM TITLE:

The word "Catalog" refers to the "Catalog of Federal Domestic Assistance (CFDA)" updated annually by the Federal Office of Management and Budget. This Catalog identifies and describes the Federal Government's domestic programs to assist the American people in furthering their social and economic progress. The catalog is no longer available in print. It can be viewed online at <http://12.46.245.173/cfda/cfda.html>.

Each program is identified by a five-digit code. The two left-most digits of the code identify the Federal agency which has been authorized funds for the program. The two digits "93" identify HHS. The next three numbers identify the program. The five-digit code is followed by the title of the program as it appears in the "Catalog of Federal Domestic Assistance."

AMOUNT:

These dollar figures represent the amount that has been obligated to the recipient during the period covered by the report. "Obligations" are funds legally set aside to be disbursed. However, the obligation of funds generally precedes the actual disbursement of funds. It is possible, therefore, that obligations reported in this column may have been disbursed to the Recipient subsequent to the period covered by this report.

COUNTY LEVEL OUTLAYS:

Funds for certain programs are allocated directly to state agencies before reaching the ultimate recipient. For these state administered programs with funds distribution based on a formula, the Department has devised a statistical proration technique which most nearly approximates the probable distribution of the funds on a geographic basis within the state to the county level. The geographical distributions of funds for each of the programs below are based on the assumption that the ratio between the number of program beneficiaries in each county and the number of beneficiaries in each state is equivalent to the ratio between the funds distributed in that county and the funds apportioned to the state. The information on the number of beneficiaries in each County is based on State reports. These programs (below) are identified as **COUNTY LEVEL OUTLAYS**. When proration methods are used, they are footnoted by a single (*) appearing to the left of the Recipient's name.

CONGRESSIONAL DISTRICTS:

The congressional district number appears in parenthesis beneath the County name. Congressional districts do not have names, only numbers, assigned within the state. Some counties include more than one congressional district, in which case the number for each congressional district is shown. If the congressional district is designated as being at large, the words "At Large" are shown instead of a number.

INDEPENDENT CITIES:

Certain cities in the United States are politically independent of the county. Such cities are footnoted by a double asterisk (**) next to the city name. If there are Independent Cities in this report, they are treated in the same manner as counties.
