U.S. Department of Transportation

U.S. Department of Transportation (DOT) is the lead federal agency responsible for transportation in the United States. DOT helped establish the *National Standard of Excellence* criteria that qualify employers to become Best Workplaces for CommutersSM. DOT is especially interested in how commuter benefits can help relieve traffic congestion.

U.S. Environmental Protection Agency

The U.S. Environmental Protection Agency's (EPA) mission is to protect human health and to safeguard the natural environment—air, water, and land—upon which life depends. For 30 years, EPA has been working for a cleaner, healthier environment for the American people.
