Of the 55,557 cases, the Commission received complete guideline application information for 48,222. Of these, 202 were excluded from all calculations in the table, except those for Use of a Minor, Reckless Endangerment, and Acceptance of Responsibility, due to missing Chapter Three adjustment information. Excluded cases for the other Chapter Three adjustments were: Use of a Minor (116), Reckless Endangerment (118), and Acceptance of Responsibility (256).
