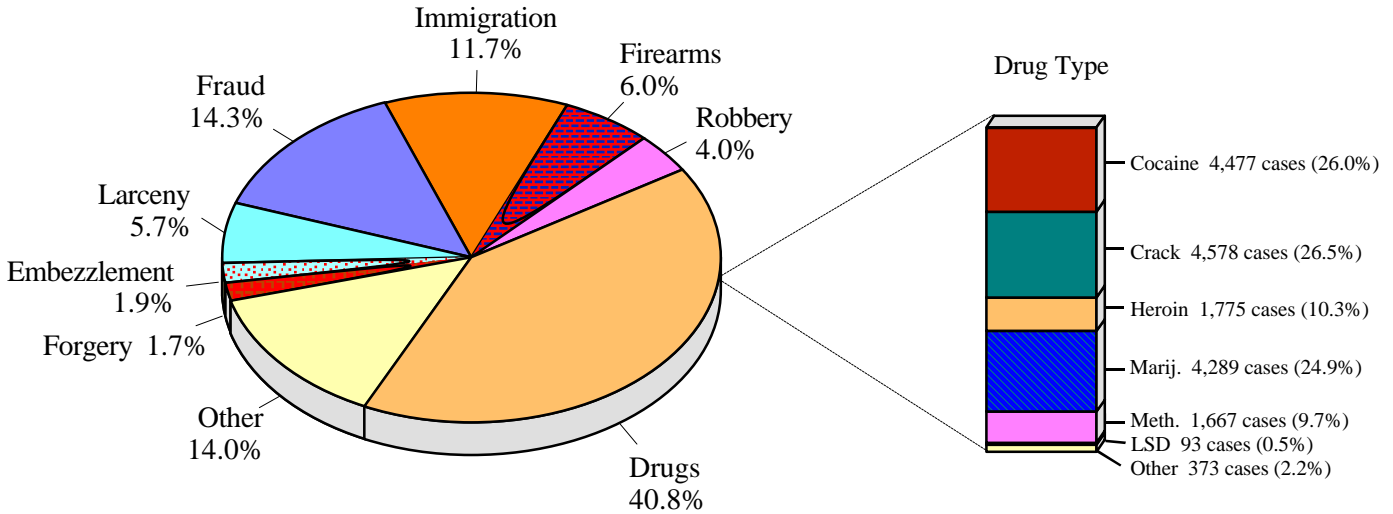


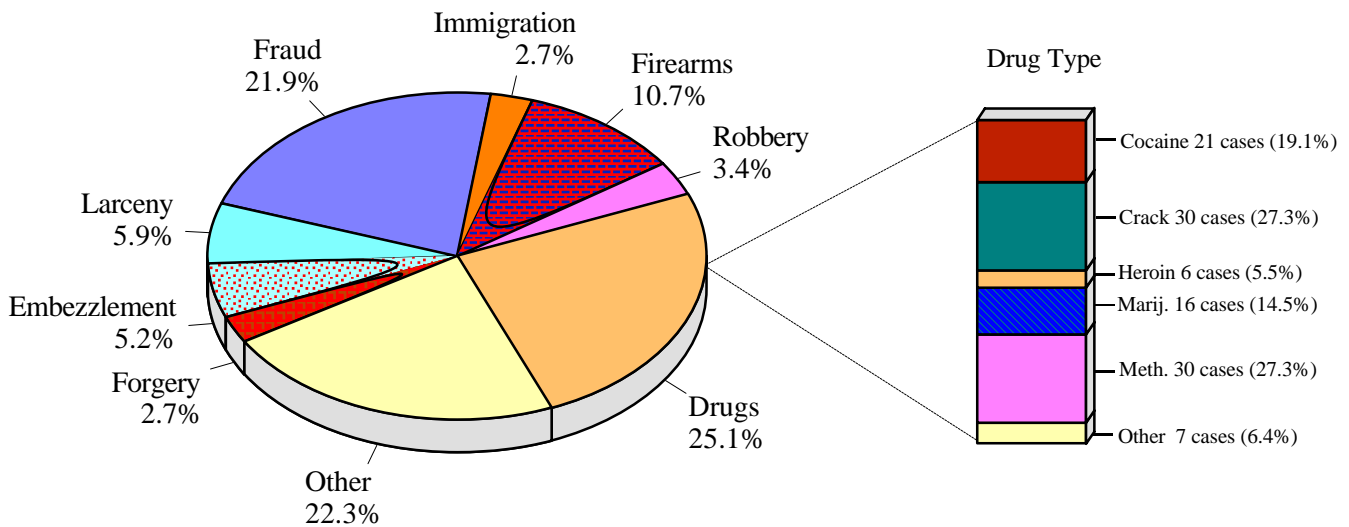

Of the 42,436 guideline cases, 8,615 cases with zero months prison ordered were excluded. In addition, 370 cases were excluded due to one or both of the following reasons: missing primary offense category (74) or missing or indeterminable sentencing information (330).

Of the 439 guideline cases from the State of Oklahoma, 107 cases with zero months prison ordered were excluded. In addition, one case was excluded due to missing or indeterminable sentencing information.
