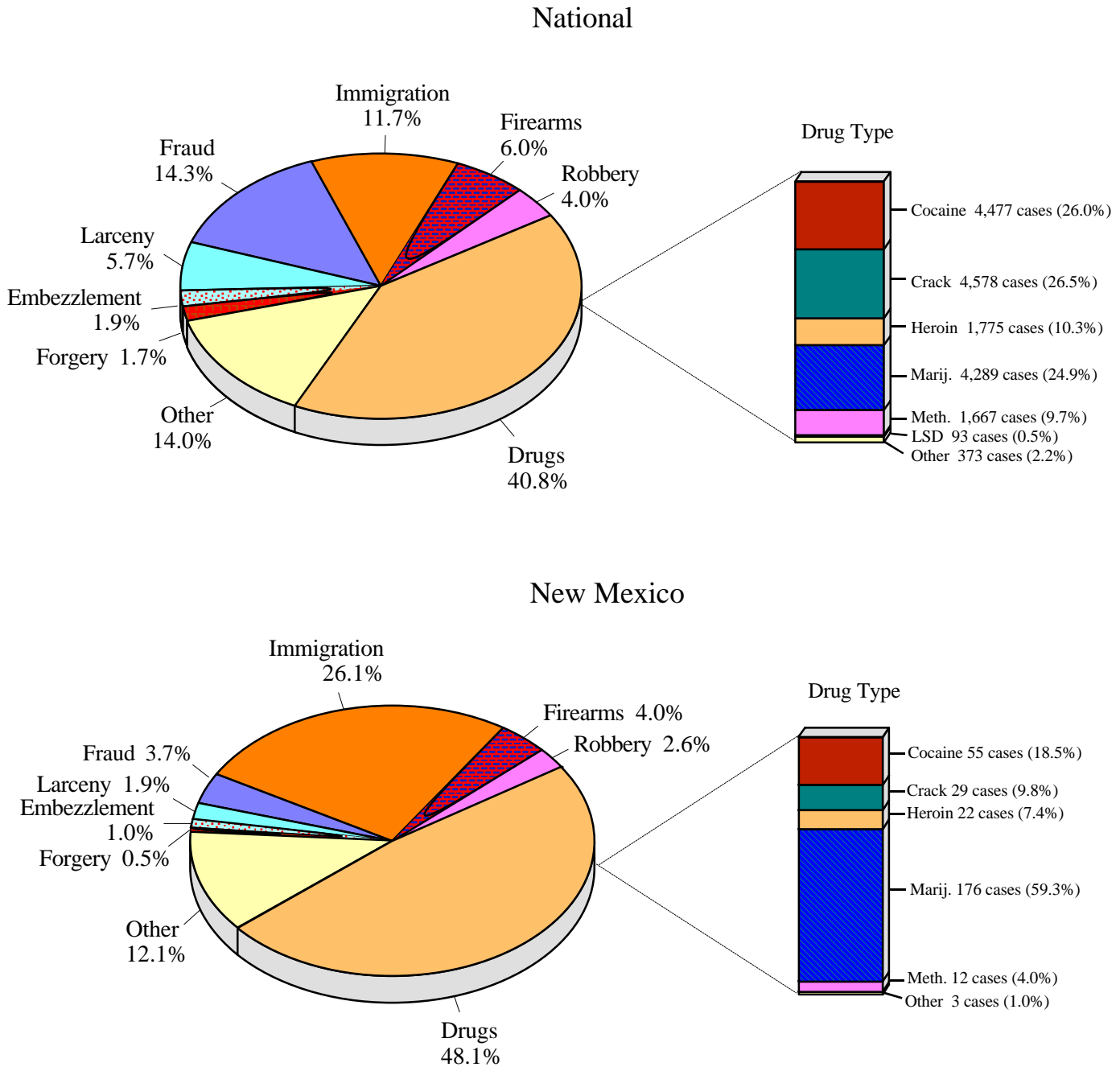

Of the 623 guideline cases from the District of New Mexico, 459 cases were excluded due to one or more of the following reasons: defendant ineligible for non-prison alternatives (454), missing primary offense category (5), or missing sentencing information (4).
