The CDFI Fund's \$50,000 technical assistance grant will help CommunityWorks expand its activities by underwriting the costs of a market analysis, the development of new loan products, and the improvement of internal financial management systems.

The Center for Rural Health Development, Inc. (the Center) is a private nonprofit corporation with the mission to improve health care services in rural areas of West Virginia. The Fund's \$1.7 million award will enable the Center to leverage loan fund dollars to stimulate approximately \$10 million worth of capital investment supporting its purpose of building and strengthening West Virginia's rural health infrastructure. Specifically, the Center will use the award to provide business loans, commercial real estate loans, and loans for community facilities to health care providers. In addition, the Center will use a portion of the award to provide development services to potential and current loan applicants. Approximately 56% of this award will be targeted to Hot Zones.

The objective of the Lightstone Community Development Corporation (LCDC) is to encourage community development through providing microloans to residents of distressed rural communities. LCDC is being awarded a \$25,000 Technical Assistance grant. The grant will be used to increase operating efficiency through purchase of accounting and financial management software and related staff training. Additionally, the grant will be used to obtain professional consulting services in the areas of strategic planning, product development and marketing.

Lightstone Community Development Corporation (LCDC), formed in 1994, operates a microenterprise loan program and a Welfare to Microenterprise Program that provides microenterprise loans to welfare recipients and assists them in moving to self-employment. LCDC currently serves seven rural counties in West Virginia. The CDFI Fund's \$270,000 award (\$250,000 capital grant and \$20,000 technical assistance grant) will help LCDC carry out its business plan that seeks to expand its Welfare to Microenterprise program statewide over a five-year period and help build the organization's capacity as a lender. The award is the CDFI Fund's first Core Component award in West Virginia.
