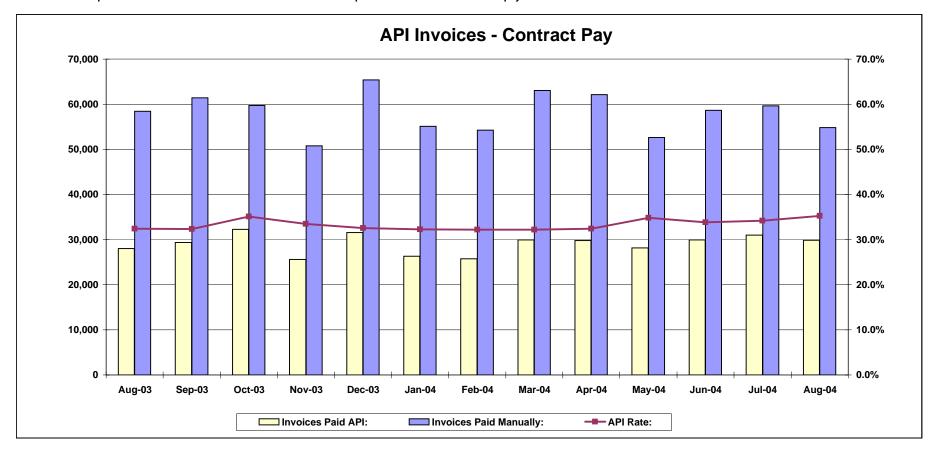
# **API Invoices - Contract Pay**

Presented on this DFAS Columbus Contract Pay chart is a 13 month view, by month, of invoices paid via the Automatic Payment of Invoices (API) system as a percentage of total invoices paid. The total of invoices paid each month varies between 76 thousand and 97 thousand invoices. Invoices not paid via API are paid manually. Invoices paid include classified invoices and do not include voided payments. The percentage of invoices paid via API varies between 32% and 35%.

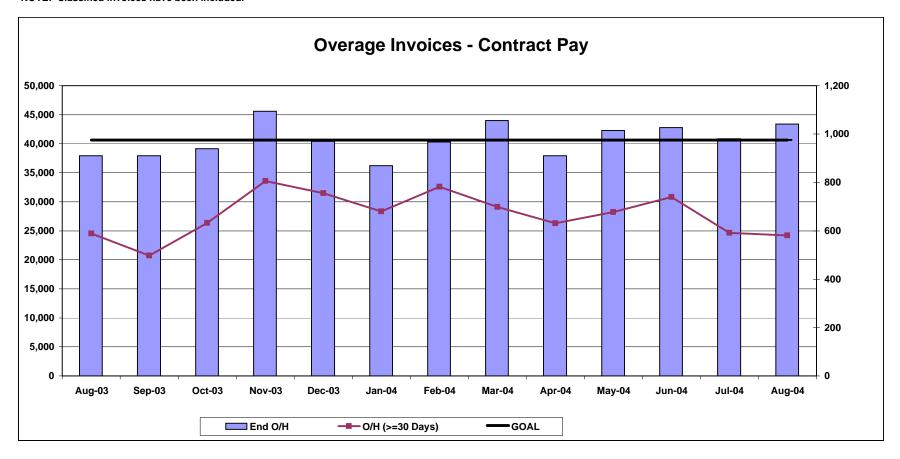


# **Overage Invoices - Contract Pay**

Presented on this DFAS Columbus Contract Pay chart is a 13 month view, by month, of the end of month figures for overage invoices on-hand, total invoices on-hand and overage percentage. Classified invoices have been included. The goal for overage invoices on-hand is not to exceed 975 invoices. An invoice is considered overage if it remains on-hand for 30 days or more. Total invoices on-hand vary between 36 thousand and 46 thousand invoices. Overage invoices on-hand vary between 497 and 806 invoices. The overage percentage varies between 1.3% and 1.9%.

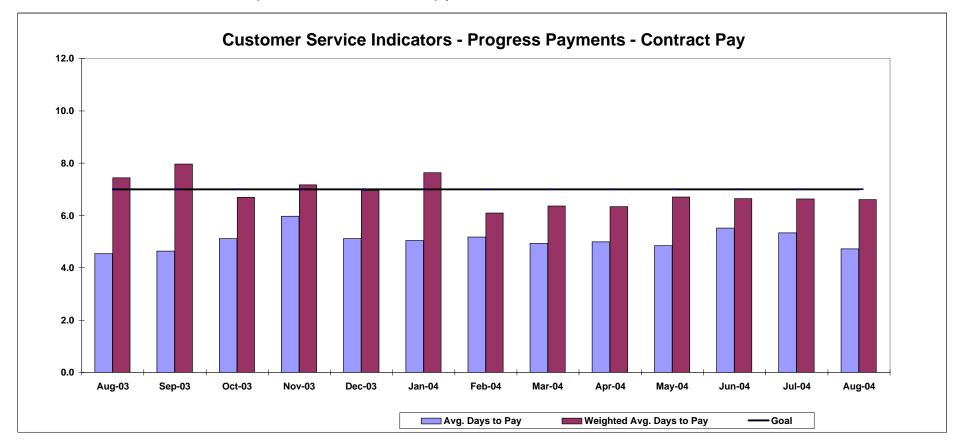


## **Customer Service Indicators - Progress Payments - Contract Pay**

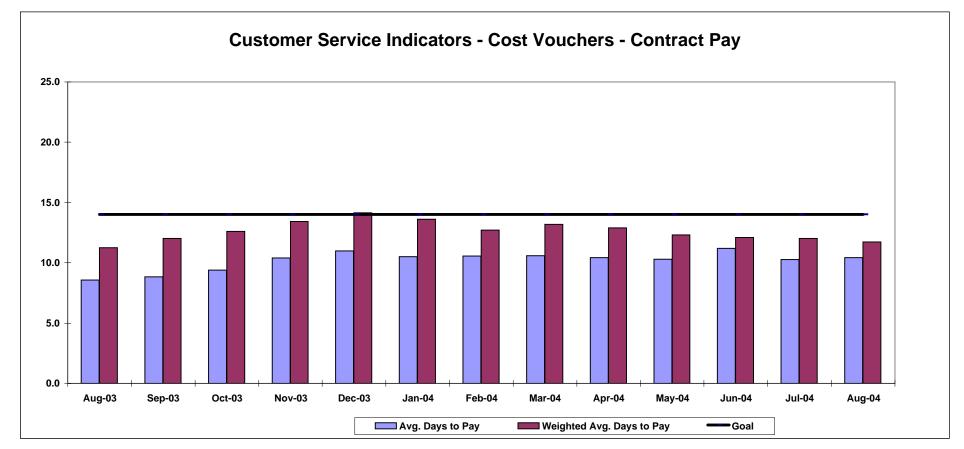


# **Customer Service Indicators - Cost Vouchers - Contract Pay**

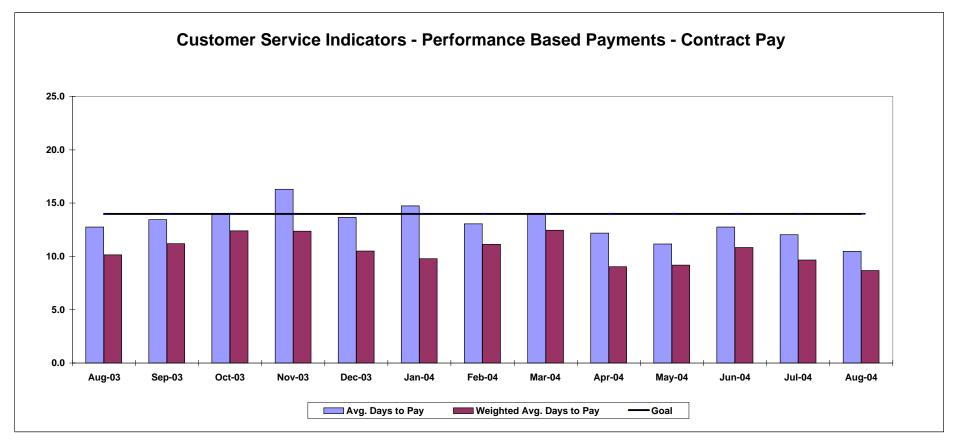

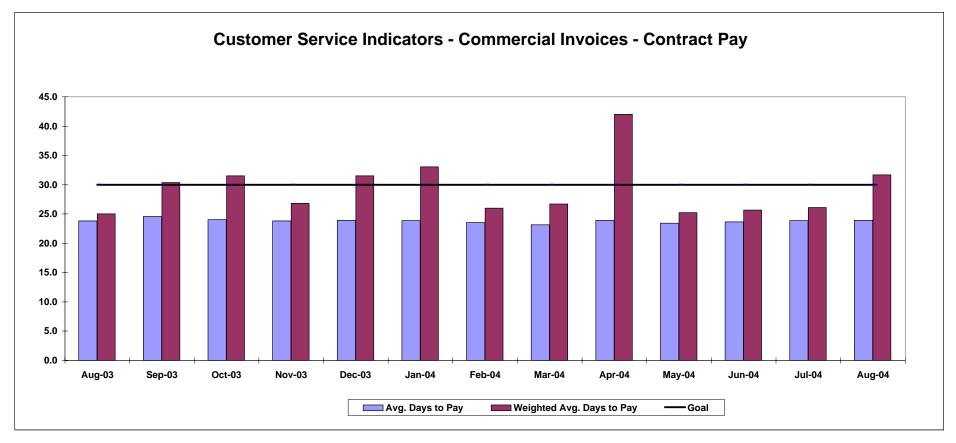
