Best Workplaces for CommutersSM is a joint U.S. Environmental Protection Agency (EPA) and U.S. Department of Transportation (DOT) voluntary partnership program designed to promote commuter benefits that reduce traffic congestion, employee stress, and air pollution. By meeting a higher standard in employer-provided commuter benefits, your organization can earn the Best Workplaces for CommutersSM designation and get a guaranteed spot on the prestigious national list. Once on the list, you will:

- Receive local and national recognition for being a great place to work.
- Be viewed as a leader in employee benefits.
- Gain a competitive advantage in recruiting and retaining the best workers.
- Demonstrate a commitment to employees, the community, and a clean environment.

Additionally, as one of the Best Workplaces for CommutersSM, you'll gain access to an exclusive suite of tools and resources. These resources, described in the following pages, can help you enhance your existing commuter benefits and create new ones that attract and retain the best and the brightest employees.

Exclusive Logo and Designation

By offering an outstanding commuter benefits package that meets EPA's criteria, you'll earn the right to use the Best Workplaces for CommutersSM designation and logo in advertisements, job announcements, on Web sites, and in other promotional materials. Using the designation and logo will demonstrate a commitment to a commuter-friendly workplace, help attract and retain the best employees, and position your organization as a leader in employee benefits and environmental programs.

Public Recognition and Media Assistance

One of EPA's primary goals is to recognize employers that make the list. First and foremost, EPA helps employers gain positive local media coverage of their commuter benefits programs. Since the inception of Best Workplaces for CommutersSM, the program has received more than 100 media spots from around the country, many of which highlighted local employers offering outstanding commuter benefits packages. Across the nation, people read about and watched companies being recognized for encouraging their employees to use alternatives to drive-alone commuting. Qualifying employers also receive an honorary certificate for being commuter-friendly and environmentally responsible, and are highlighted in marketing materials and on the Web site.

Networking Opportunities

All employers that qualify for the list, regardless of size or location, will gain valuable insights from the program's networking opportunities. With nearly 900 Best Workplaces for CommutersSM covering more than 1.8 million commuters nationwide, employers can exchange ideas on managing commuter benefit programs, lessons learned, and tricks of the trade so that all can benefit. For example, EPA sponsors workshops at national conferences and regional forums, creating numerous opportunities for employers who want to upgrade their commuter benefits programs.

Technical Assistance

When you make the list, you're assigned an Account Manager, who serves as a single point of contact to keep program administration easy. Account Managers are available via phone, fax, and e-mail to answer questions, help access resources, and provide new information on commuter benefits and program developments. With this dedicated service, you'll always have the attention you need to keep your commuter benefits program state-of-the-art. You'll also have access to a Members-Only Toolkit with ideas on how you can take full advantage of promoting the Best Workplaces for CommutersSM designation—both internally and externally. The Toolkit also features information on innovative commuter benefits and events highlighting alternative transportation.
