ANCHORAGE CONSUMER PRICES UP 1.0 PERCENT IN THE FIRST HALF OF 2004—2.8 PERCENT ABOVE A YEAR AGO

Consumer prices in the Anchorage metropolitan area advanced 1.0 percent in the first half of 2004 according to the Bureau of Labor Statistics of the U.S. Department of Labor. Regional Commissioner Richard J. Holden said compared to the same period a year ago, prices increased 2.8 percent. Annual increases in housing, followed by food and beverages, led the advance in the overall index. The area's Consumer Price Index for All Urban Consumers (CPI-U) advanced to 165.6 (1982-84=100) during the first half of 2004. This means a market basket of goods and services that cost \$100.00 in 1982-84 would have cost \$165.60 during the past six months. Local area CPI data are not seasonally adjusted.

The housing index rose 0.9 percent during the first half of 2004. In the same period, the shelter component of housing advanced 0.5 percent and fuels and utilities rose 7.7 percent. Electricity prices increased 6.4 percent and utility natural gas service prices jumped 12.6 percent from six months ago. Household furnishings and operations decreased 1.3 percent since the second half of 2003. The overall housing category increased 2.2 percent between the first half of 2003 and the first half of 2004.

Prices paid for food and beverages rose 1.9 percent in the first half of 2004. Grocery prices, represented by the food at home index, advanced 2.5 percent for the same period and increased 5.6 percent from a year ago. Since the second half of 2003, the cost of dining out increased 2.1 percent and increased 3.4 percent over the year. Prices paid for alcoholic beverages edged down 0.1 percent in the past 6 months, but advanced 0.4 percent in the past 12 months. For the past 12 months, the overall food and index rose 4.5 percent.

Transportation prices advanced 0.4 percent during the first half of 2004, and increased 1.9 percent since the first half of 2003. Gasoline prices advanced 2.0 percent during the past six months and consumers paid 6.6 percent more for gasoline than they did a year ago.

Prices for recreation advanced 1.5 percent since the second half of 2003, while over-the-year the index rose 2.1 percent.

The miscellaneous other goods and services index advanced 2.3 percent in the past six months and 2.6 percent over the year.

The education and communication index inched up 0.1 percent during the first half of 2004 and advanced 2.2 percent from a year ago.

Apparel prices decreased 2.8 percent in the last six months, but increased 2.7 percent over-theyear. Apparel was the only major expenditure category to post a semi-annual price reduction.
