### **CDFI** Institution-Level Report Instructions

### DON'T FORGET!

- Allow enough time to review the survey, gather data, and enter the entire survey by your reporting due date. The date that you click the submit button will be recognized as the date the report was submitted to the Compliance and Monitoring Division.
- Print the final PDF of your completed survey for future reference and store it in a file with any backup notes you may have used to provide responses. You may receive a call to discuss your survey responses.
- Submit financial statements.

#### CIIS Requires Responses to All Questions

The organization must provide a response in every "active" field in order to submit the survey. Fields that are not active, or not required, are grayed out on the screen. CIIS determines that a table is complete when the user checks the "Complete or Not Applicable" box that accompanies each table. Throughout the survey entry process, CIIS will notify you if you try to leave an entry screen without entering all required fields. CIIS also provides a survey status page for users to verify the completion of each survey section.

When appropriate, CIIS will allow "Don't Know" and/or "Not Applicable" as a valid response to a question. These options are provided in a dropdown menu next to the entry field. For every active field, you must either type a response OR select from the "Don't Know" / "Not Applicable" dropdown menu if you cannot provide the requested information.

- Don't Know (DK): Use "Don't Know" when the question is valid for the organization, but you do not know the answer to the question. For example, the organization provides technical assistance, but you do not know how many hours of group-based training were provided during the reporting period.
- Not Applicable (NA): Use "Not Applicable" to indicate that the question is not valid or applicable to the organization. Please do not use "Not Applicable" for a "\$0" or "0" response. For example, if the organization purchases loans but did not purchase any loans during the reporting period, the number of loans purchased is "0". However, if the organization does not purchase loans at all, then the number of loans purchased is "Not Applicable". Please note that "Not Applicable" does NOT mean not available (use "Don't Know" for not available).

When every required field contains a response, the Status Page will display "Complete" for each survey section and the "Submit" button on the final page will become active.

#### Hot Zones

#### **Economic Development Hot Zones:**

• Metropolitan Economic Development Hot Zones are census tracts with:

a) A minimum population of 1,500,

b) An unemployment rate at or above 1.5 times the national average,

c) A poverty rate at or above 20 percent, and

d) A median family income at or below 80 percent of the metropolitan area median income

Demonstrate Low-Income Homeowner Cost-Burden:

a) Median monthly homeowner cost that exceeds 30 percent of the gross monthly income of a low-income household and

b) A median family income that is at or below:

• 80 percent of the metropolitan area median income (for metropolitan census tracts), or

• the greater of 80 percent of the statewide non-metropolitan median family income or the national non-metropolitan median family income (for non-metropolitan counties or census tracts).

#### **Combination Hot Zones**

Combination Hot Zones are geographic units that meet both the criteria for Economic Development Hot Zones and Housing Hot Zones.

#### Native American Areas

Additionally, all Native American Areas and similar entities that are eligible Investment Areas - but do not meet the above Hot Zone definitions - are automatically considered to be Hot Zones.

#### 15) Are 50% or More of the Customers or End Users American Indian, Alaska Native, or Native Hawaiian or Located in Native American areas?

#### 16) Native American Community Activities

Enter the name of each Native American Community served during the reporting period. Include communities that received financing or Development Services.

#### D. Staff and Consultants: # of Full-Time Equivalents (FTEs)

For each category, enter the organization's full-time equivalent (FTE) resource allocation at the reporting period end. Include all of the organization's full- and part-time employees, contractors, consultants, and volunteers that perform ongoing operations. Exclude temporary employees and professional services conducted outside of the office by third parties such as accounting, bookkeeping, and legal counsel.

One FTE is a 35-hour, or more, work week. In calculating the number of full-time equivalents, part-time employees should be combined.

Example (1): Two part-time employees that each work 17.5 hours per week should be combined to count as one FTE. (17.5 hours X 2 = 35 hours) Example (2): If a full-time loan officer spends 28 hours per week on lending activities and 7 hours per week providing training, this person would count as .80 (=28/35 or 80%) FTEs Dedicated to Lending/Investing activities and .20 (=7/35 or 20%) FTEs Dedicated to Development Services.

#### 17) FTEs Dedicated to Lending/Investing

Enter the organization's total FTEs dedicated to loan/investment underwriting and outreach, loan administration, servicing, and collections at the reporting period end.

#### **18) FTEs Dedicated to Development Services**

Enter the organization's total FTEs dedicated to providing Development Services at the reporting period end. These counseling, technical assistance and training activities may be performed by technical assistance staff, loan officers, or other staff.

#### **19) FTEs Dedicated to Financial Services Other than Lending/Investing**

Enter the organization's total FTEs dedicated to services such as opening checking or savings accounts, check cashing, issuing money orders and certified checks, deposit-taking, safe deposit box services, or other similar services at the reporting period end.

#### 20) FTEs Dedicated to Administration and Other Activities

Enter the organization's total FTEs dedicated to any activities not covered in the categories above, including, but not limited to, finance, human resources, fundraising, policy, administration, and other overall management at the reporting period end.

#### 21) Total FTEs

CIIS will display Total FTEs calculated by summing the FTEs you entered in each category.

#### 22) Consultant/Contractor FTEs

Enter the organization's consultant/contractor FTEs at the reporting period end. Include individuals covered by management contracts. This entry is a subset of the Total FTEs indicated above. Therefore, this response cannot be more than the Total FTEs displayed.

### **II. FINANCIAL POSITION**

In this section of the survey, report on the overall financial position of the organization. This section will require you to use the Organization's Balance Sheet or Statement of Financial Position, as well as the Income and Expense Statement for the reporting period.

You must submit the financial statements used to complete this survey to the Fund. The survey submission is incomplete without the financial statements. If

more than one organization is submitting a survey (for example, the Awardee and an Affiliate to whom the Awardee passed on a portion of the award), you may submit separate audited financial statements for each entity OR combined statements, provided that the financial position of each reporting entity is reported separately (combining financial statements).

Note: For venture capital funds, all questions in this section pertain to the investing entity(ies), not the managing entity, unless otherwise noted.

#### A. Lending/Investing Pool

In this section, identify the sources of funds that make up the organization's lending and investing pool.

#### 23) Investment Capital Table

Use the organization's Balance Sheet or Statement of Financial Position, historical records, and associated notes to enter all of the sources of loan or investment capital at the reporting period end. Include both capital available to lend or invest as well as deployed capital. Record only capital that is reflected in the Balance Sheet or Statement of Financial Position. Do not include undrawn lines of credit. If the organization makes grants as well as loans and investments, do not include the capital used for such grants. For venture capital funds, report on the investing entity(ies), not the managing entity, and record all paid in capital; committed capital will be reported separately.

Use one row in the table for each distinct capital source with the same interest rate and term. If a single source provided two loans or investments with different terms, the organization must use two separate entry rows.

Note: When completing the table, "Internal Funds" is the source of capital for retained earnings (for-profits and credit unions) and certain types of net assets (non-profits). The types of net assets included here are earned income and any net assets whose source cannot be identified. In the Type of Capital options, these are all combined in a single line item: Net Assets - Other OR Retained Earnings. Please note that for non-profits, grants are not included in "Net Assets - Other" unless their source and value cannot be identified.

Example: Two years ago the organization received a \$100,000 grant from the ABC Foundation. If the organization did not track the grant separately and therefore cannot distinguish its balance from other net assets, then it should be categorized as "Net Assets - Other." If the organization did track the grant separately and knows the balance, then it should be categorized as "Net Assets - Grants."

#### ENTERING DATA

**Entering Rows:** Use the "Add Row" button on the table to add a row for each distinct source of capital. For each row initiated, CIIS will provide a dialog box for entering the details of that investment. After completing the entries, use the "Add

Row" button in the dialog box to enter the data in to the Investment Capital Table. Click the "Cancel" button if you decide not to add the new row.

**Modifying Rows:** Select the row to modify by using the radio buttons to the left of each row. You may only modify one row at a time. After selecting a row, use the "Update Row" button to reopen the dialog box that will allow you to change the data entered for that row. When you have completed the changes, use the "Update" button to update the data in the Investment Capital Table or the "Cancel" button to leave the data unmodified.

**Deleting Rows:** Select the row you would like to delete by using the radio buttons to the left of each row. You may only delete one row at a time. After selecting a row, use the "Delete Row" button to delete the row.

Amount	For each row, enter the Amount of lending/investing capital remaining at the reporting period end. For loans, enter the outstanding principal balance as it appears in the Balance Sheet or Statement of Financial Position.

#### 24) Investment Capital Summary Table

This is a summary table. The user does not enter data in this table.

This table automatically summarizes all investment capital entered in the Investment Capital Table. The table includes a row for the weighted average cost and term of debt capital. If the totals for the various capital sources are incorrect, please modify the data in the Investment Capital Table as appropriate.

# 25) Off Balance Sheet Resources Committed to the Organization for Lending/Investing

Enter the amount of any additional lending and investing funds that have been committed to the organization, but that do not appear on the financial statements for the reporting period. Include grants, equity, debt, and any undrawn lines of credit the organization expects to use for lending/investing. For venture capital funds, include all committed capital.

#### B. Financing Commitments the Organization has Made to its Borrowers/Investees

# 26) Financing Commitments to Borrowers/Investees at Reporting Period End

Enter the amount of loans and equity investments that the organization intends to provide to borrowers/investees which it has not yet disbursed, but for which the organization has reserved cash, cash equivalents, or other assets to fund at a later date. For example, include a loan that is approved by a loan committee and is not yet disbursed; a loan that has been provisionally approved but will not be closed until a borrower meets certain terms and conditions; and undisbursed portions of closed loans.

#### 28) Current Assets

Enter the organization's current assets at the reporting period end. Note: Depository Institutions do not respond to this question.

#### 29a) Loan Loss Reserve -- Accrual

Enter the loan loss reserve set aside for loan or investment losses through accounting-based accrual reserves at the reporting period end. Accrual loan loss reserves typically appear as a contra-asset on the balance sheet. Note: Loan loss reserves are not the expense listed on the Income and Expense Statement.

If this entry is pre-filled by CIIS and the information is correct, please skip to the next question. If this entry is pre-filled by CIIS and the information is incorrect, please enter the correct information.

#### 29b) Loan Loss Reserve -- Cash

Enter the Loan Loss Reserve set aside for loans or investment losses in the form of cash reserves, if any, at the reporting period end. Some funders, such as the Small Business Administration (SBA) Microloan Program, require a cash reserve as a condition of their assistance. Note: Loan Loss Reserves are not the expense listed on the Income and Expense Statement.

#### 29c) Depository Loss Reserves

#### 31) Current Liabilities

Enter the organization's current liabilities at the reporting period end. Note: Depository Institutions do not respond to this question.

#### 32) Total Liabilities

Enter the organization's total liabilities at the reporting period end.
