Interagency Management Division

The Interagency Management Division (MEA) is strategically located in the GSA Office of Governmentwide Policy organization to provide leadership in Governmentwide initiatives as mandated by E.O. 13011 of July 16, 1996.

This is accomplished by:

—Providing strategic, technical and management services to four interagency groups as identified in this brochure— CIOC, ITRB, FAC, and the CFOC.

—Conducting studies, analyses, and assessments related to pressing issues of Federal IT, finance, and procurement vital to accomplishing a seamless Government.

—Working with OMB and other Federal agencies to identify opportunities for common policy measures and standards for IT, financial, and procurement areas, and publicize related lessons learned and promising practices.

— Facilitating Federal interagency funding of cross-agency initiatives and the activities and services of other GSA offices in support of inter-agency groups.



Chief Information Officers Council (CIOC)

A group consisting of senior executives from the Office of Management and Budget (OMB) and top Federal agencies that serve as the principal interagency forum for improving practices in the design, modernization, use, sharing, and performance of Federal Government agency information resources.

Information Technology Resources Board (ITRB)

A board of IT professionals, program managers, and acquisition experts with experience developing, acquiring, and managing information systems. The ITRB conducts reviews of agency mission-critical systems and makes recommendations for their improvement and continued success.



Federal Acquisition Council (FAC)

The FAC is an interagency council consisting of senior executives that creates an acquisition workforce of mission-focused business leaders, optimizes technology as a key business enabler, leads collaboration to achieve desired business results, and effectively integrates socio-economic programs in the Federal acquisition system.



Chief Financial Officers Council (CFOC)

The CFO Council consists of Federal senior executives that advise agencies and coordinate their activities on financial management matters, such as (1) implementing Federal accounting standards, (2) consolidating and modernizing debt collection for major receivable accounts on financial systems, (3) improving the quality of financial data and information standards, (4) strengthening internal controls, and (5) developing legislation affecting financial operations and organizations.
