OPM/GSA/DHS Interim Protocol

- Office of Homeland Security sponsored Committee of government security professionals developed draft based on OPM/GSA/DHS interim protocol
- Reflects All-Hazards approach
- Two Sections to the protocol:
 - Natural Hazards
 - Man-made Hazards/Terrorism



Scope

- Addresses Federal employees and contractors in all Executive agencies in the NCR (National Capital Region)
- Coordination among all Federal State and Local agencies
- Impact on Private Sector
 - Many companies in NCR follow Federal Government lead



Natural Hazards

- The current protocol regarding decision-making for inclement weather or other natural hazards remains unchanged
- OPM has lead responsibility
- Natural Hazards include (for example):
 - Snow
 - Other severe storms / Hurricanes
 - Floods
 - Earthquakes




Man-Made Hazards / Terrorism

- Man-Made Hazards/Terrorism may include actual or threatened:
 - Armed Attack
 - Bombs/Explosives
 - Chemical Weapons
 - Biological Weapons
 - Radiological Dispersal Devices ("Dirty Bomb")
 - Nuclear Weapons





Training












DDOT has identified 25 corridors extending from downtown DC as emergency/event routes. Most of these routes extend to the Capital Beltway (I-495) and beyond. Additionally, critical intersections along these routes have been identified for better monitoring and staffing by law enforcement





TRANSPORTATION EPARTMENT OF





Unique signs along Event Routes were installed for easy identification by the motoring public and authorities. This was done using emergency funds from DHS. Both MDOT and VDOT have also installed event signs for regional consistency.









Through Federal and local funding, DDOT has been able to fund several key transportation projects including:

Closed Circuit TV Cameras

100 traffic surveillance cameras were installed along evacuation routes to monitor traffic in the event of an emergency










Traffic Signal Controllers Cross-Jurisdictional Signal Coordination

New controllers are being installed at all intersections on the evacuation routes that are regulated by traffic signals.










A coordinated emergency evacuation traffic signal timing plan has also been developed. DOTs in the region have reached agreement on a common 240-second cycle that will assist traffic flow and gridlock mitigation.



Motor Carrier Management and Threat Study

- Initiated by the US DOT Volpe center in April 2003.
- Develop a comprehensive motor carrier
 Management program for the district of Columbia to improve truck operations and safety within the city.
- Review and modify truck loading and unloading Operations and policies to improve deliveries and reduce traffic congestion and improve air quality.
- Address security concerns related to truck operations within the district of Columbia.





Capitol Police Truck and Bus Monitoring (CAPTM) System

•Collaborative project between DDOT and Capitol Police to manage trucks and buses around capitol hill.

•Project components include:

- -Signal Preemption
- -Truck detection and Identification System
- -CCTV Monitoring System
- Phased approach design concept
 - -Pilot Phase (CCTV only)
 - -Expanded phase (Signal control & Truck Monitoring)






HazMat Route Restrictions

- Legislation before council to prohibit hazmat shipments through DC
- Concern about terrorism risk of HazMats near capitol & agency headquarters
- Issue about federal preemption
- Need federal participation & coordination
 - Expertise: terrorism v. Transportation risks
 - Expertise: interstate commerce issues
 - Coordination: ITS/CVO v. Random searches
 - Coordination: regional approach required







FEMA COOP Program

- Serves as the DHS Lead Agent for Federal Executive Branch COOP (Continuity of Operations)
- Issues guidance in cooperation with GSA and OPM
- Chairs the COOP Working Group (CWG)
- Conducts assessments and exercises to validate Federal Executive COOP readiness
- Assists in COOP planning and implementation and provides oversight to Federal agencies as required
- Provides guidance and support to State and local governments as required



FEMA Notification Protocols

Communication Priorities

- 100% contact between Regional management and all Region III employees
- 100% contact of all ERG members to carry out Regional essential functions
- 100% contact of all non-ERG members to provide an understanding for future communication and expectations

Normal Call-Down Procedures

- "Communicator"
- Regional Alert Roster
- ROC/FEMA MOC Number also provides critical information

COOP Scenario

- Situation-dependent
- Regional Director or Designee determines necessary communication systems required



FEMA Shelter-in-Place

- Basic Steps During a Chemical Emergency
 - Shut and lock all windows and doors
 - Turn off all air handling equipment (heating, ventilation, and/or air conditioning)
 - Go to a pre-determined sheltering room (or rooms)
 - Seal any windows and/or vents with sheets of plastic and duct tape
 - Seal the door(s) with duct tape around the top, bottom and sides
 - Turn on a TV or radio and listen for further instructions.
 - When the "all clear" is announced, open windows and doors, turn on ventilation systems and go outside until the building's air has been exchanged with the now clean outdoor air

Additional Considerations

- Determine if all employees will shelter or if some will leave the building before shelter procedures are put in place
- Develop an accountability system
- Duties should be assigned to specific employees
- Drills should be planned and executed on a regular basis
- Consider the safety needs of people with disabilities

FPS Operations in NCR

- Emergency Response to nearly 800 Federal Facilities
- Conducts Regular Federal Security Risk Management (FSRM) Surveys
- Implement and Recommend Proactive Security Enhancements
- Manages nearly 5,300
 Federal Contract Guards
- Coordinates with over 40 Federal, State and Local agencies in NCR





FPS MegaCenter Operations

- Handle about 10,000 calls for service per annum
- FPS Comm Center
- Alarm monitoring in most FPS jurisdiction facilities
- Responsible for Interagency Notifications - Cascade
- Inter-connected with regional agencies thru WAWAS, RICCS, etc.
- Redundant Complete Backup with other 4 MegaCenters






Occupant Emergency Planning

- Required of Federal Facilities under 41 CFR 20.103
- FPS and GSA responsible for assistance in preparation and implementation of OEP
- FPS law enforcement/security subject matter expertise for Designated Official development of OEP
- FPS links OEP Organization with Local Emergency Services Community

Local Community Emergency Services Response




Continuity of Operations Plans

- Required under PPD 67 & Federal Preparedness Circular 65
- FPS provides law enforcement advice
- FPS provides exercise assistance
- FPS is the link between the COOP Organization and Emergency Services Community
- FPS protects some COOP sites and Principals.

- NIMS Principles:
- Incident Command & Mgt.

Preparedness

- FPS/NCR Initiatives:
- Integrating ICS in daily ops
 - Increasing use of Unified Command and Area Command Principals
- Involved/Hosted numerous interagency exercises.
- Extensive ICS training and practical exercises to all FPS levels
- Developing/Implementing MOU/MOA Mutual Aid Agreements



FPS Role in NIMS (Cont.)

- NIMS Principles:
- Resource Management

Comm & Info Management

- FPS/NCR Initiatives:
- Applying ICS terminology in daily ops for resources
- Studying NCR equipment interoperability with FPS
- Including interagency resource availabilities in all OpPlans
- Developing Comm.
 Interoperability in NCR
 - Use of cascade interagency notification system
 - Active participation on JTTF



Emergency Preparedness Programs

- FPS Role in OEP/COOP Planning, Training & Drills
- FPS is providing NIMS/ICS training to all officers and staff
- FPS engaged in COG
- FPS participated in 6 exercises in FY 03
- FPS hosts an average of 2 Emergency Preparedness Incident Command Simulations exercises per annum
